THIS SERVICE INVOICE REFLECTS BIOPHOTONICS SERVICE FEES FOR DAN LIER AND KATILYN BIVERS BASED ON THE AGREEMENT MADE AS LEGAL REPRESENTATIVES OF BODY BALANCE SYSTEM. ETC WAS PATIENT AND SUPPORTED THE TRADE AGREEMENT FROM OCTOBER, 2022 THROUGH MAY 2023 IN SPITE OF THE SIGNIFICANT NEGATIVE IMPACT TO OUR FIRM. THE AGREEMENT WAS TO PROVIDE LIER AND BIVERS BIOPHOTONICS TREATMENTS UTILIZING THE BEST-IN-THE-INDUSTRY TECHNOLOGY IN EXCHANGE FOR THE TEMPORARY USE OF A HEADLESS, ZERO GRAVITY DEVICE UNTIL BODY BALANCE SYSTEM COMPLETED OUR CUSTOM FABRICATED DEVICE BASED ON FRAZER'S DESIGNS AND SPECIFICATIONS. THIS TIME PERIOD WAS ORGINALLY PROJECTED TO BE FROM OCTOBER 2022 TO EARLY DECEMBER 2022, HOWEVER, BODY BALANCE SYSTEM FAILED TO COMPLETE THE FABRICATION WORK IN 8 WEEKS AND ULTIMATELY DELIVERED ONLY 2/3RDS OF THE PROJECT AFTER 8 MONTHS. THERE WAS DISCUSSION REGARDING THE PURCHASE OF THESE HEADLESS, ZERO GRAVITY DEVICES, BUT BODY BALANCE SYSTEM FAILED TO PRESENT AN APPROVED SOLUTION.

THE TERMS OF THIS AGREEMENT ARE CLEARLY DETAILED IN 3 SECURITY VIDEOS FEATURING LIER AND BIVERS EXPLAINING THE TERMS OF THE AGREEMENT TO ETC FRONT DESK STAFF AND LONDO WAS IN THE ROOM WHEN THE INITIAL AGREEMENT WAS MADE. HOWEVER, ON 2023.05.25, BODY BALANCE SYSTEM BREECHED THE TERMS OF THE AGREEMENT WITH THE DELIVERY OF A FRAUDULANT RECEIPT AND THIS INVOICE FOR THE VALUE OF OUR BIOPHOTONICS SERVICES IS THE BALANCED RESPONSE.

WARD PHOTONICS IS THE CORNERSTONE OF THE PHOTOBIOMODULATION INDUSTRY WITH OVER 3,000 LOCATIONS AROUND THE WORLD. OUR WELLNESS, ETC. CLINIC ON E FLAMINGO RD IS THE LARGEST WARD PHOTONICS CLINIC IN THE COUNTRY. THE COST OF A SESSION USING A SINGLE WARD LIGHT IS SET BY THE MANUFACTURER AT \$500 SO A SINGLE SESSION USING 2 WARD LIGHTS (\$264K IN EQUIPMENT CAPITALIZATION) HAS A FAIR-MARKET, WELL-ESTABLISHED SERVICE FEE OF \$1,000.
