

# PRAIRIE PRIDE EQUIPMENT CONSULTING & VALUATION AGREEMENT



This Equipment Valuation Agreement ("Agreement") is made and entered into on this \_\_\_\_ day of \_\_\_\_\_, 2025 by and between:

**1. Scope of Work** The Appraiser agrees to perform valuation services on the following equipment:

- Class 8 trucks
- Farm equipment
- Construction equipment

**6. Termination** This Agreement may be terminated by either party with a written notice of 30 days. The Client shall pay for all services rendered up to the termination date.

**7. Governing Law** This Agreement shall be governed by the laws of the Province of [Alberta, Saskatchewan ], and any disputes shall be resolved in the courts of [Alberta, Saskatchewan].
