Carried  Council discussed the CAO update report with no questions.
<b>Motion: CPO officer</b> <b>Res: 005-2025-08-20</b>	Moved by Karen Sliwkanich that Council appoints a new CPO officer. Zeeshan Butt has been hired by Athabasca County and will be a patrolling officer in the Summer Village of South Baptiste. Carried  Council discussed the silent auction items for the upcoming Summer Village conference in October. Was determined that the budget for this item(s) would be up to \$125.00

Council discussed the various crosswalks and signs in village. Administrator has received a quote for more permanent markings. This will be carried forward to spring.

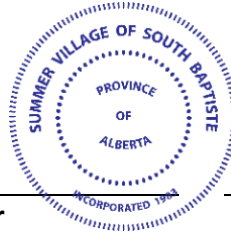
