Motion (Agenda) Res. 001-2026-03-11	Moved by Wendy Appleby that Council adopts the agenda as presented. Carried.
Motion (Regular meeting Minutes) Res. 002-2026-03-11	Moved by Todd Dutchak that the minutes of the February 18, 2026, Regular Council Meeting be adopted as presented Carried. Administrator provided financial summary reports to council.
Motion (Financial Summary) Res. 003-2026-03-11	Moved by Wendy Appleby that the financial summary results be accepted as presented. Carried Council discussed the CAO update report including the upcoming municipal sustainability requirements from the Government of Alberta. Administration to investigate if email chain of approval is still valid.
Motion (CAO update) Res. 004-2026-03-11	Moved by Todd Dutchak that the CAO report be accepted as presented. Council discussed the recent request from the Summer Village of Sunset Beach on municipal collaboration with the County of Athabasca on the public beach area. Request has been tabled for the next meeting. Council discussed the Invasive Species letter of support requested by the Alberta Summer Village Association.

Council and Administration discussed the outstanding balance on the Athabasca Regional Waste Management invoice that was sent in 2025 for infrastructure damage. Discussed the various options provided by the auditor and the proper procedures that need to be followed.

Council discussed the lawyer provided legal review/recommended changes notes on the Emergency Management contract with Morse & McLean. Council discussed the presented Legal Review Policy to clarify how contracts will be handled in the future. Karen Sliwkanich will review the policy and make recommended changes. Approval tabled for the next meeting.

Council discussed the Draft 2026 budget that was presented. Further additions were made to the Capital budget for 2026.

Motion (2026 Operating and Capital Budget Approval)

Moved by Karen Sliwkanich that Council adopts the 2026 Operating and Capital budget for the Summer Village of South Baptiste in accordance with Section 242 of the Municipal Government Act.

Council and Administration discussed the potential speed control measures on Baptiste Drive for 2026. Administration has requested quotes from a couple of contractors for the installation and removal process of speed bumps. Also researching signage and storage locations. Further discussion tabled to next meeting.

Council and Administration discussed the Strategic Plan for the Village. Discussion on a survey going out to residents for their input took place. Administration will work on the survey and the basic formatting of a strategic plan for Council discussion at an upcoming meeting.

Council discussed the recent invoice received from Town of Athabasca for Rescue services. Administration to ensure that these future costs will be included in the Level of Service discussions with the County of Athabasca. Further discussion tabled to next meeting.

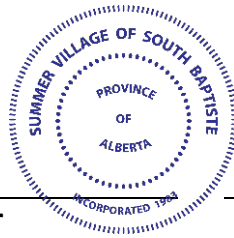
