<b>Motion(Resource Road) Res.004-2025-05-20</b>	Moved by Wendy Appleby that administrator contact Patry Contracting for quote on rehabilitation of Resource Road. Carried
<b>Motion (tables and benches) Res.005-2025-05-30</b>	Moved by Blaine Page that administrator proceed with ordering benches and picnic tables for reserve area. Also included in this will be a picnic table donation to the West Baptiste Fire Hall. Carried

Council and Administrator discussed culvert cleanouts for entire village. Admin will get quotes and advise at next meeting.

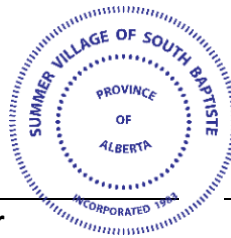
