

經常帶著美國企業主管到中國、台灣、香港 出差的楊文慶發現,美國人對亞洲文化一知半 解,常因此鬧笑話,例如面對中式大圓桌搞不 清主位在哪裡,用發撲克牌的動作遞名片,不 了解中國人為顧及面子而不願直接拒絕的作 法。因此,他主動在啟程到亞洲前,為企業主 管舉辦特別講習,以親身經驗為例,介紹中國 歷史、文化及慣用成語背後的故事。

每年都組團前往雲南山區的楊文慶說,當地風光秀麗,但山路也十分原始難行。雲南少數族裔希望工程由他的大姊夫丘才廉及大姊創辦,是加拿大登記的非營利組織,以捐贈實體學校建築及設備為主,美金2萬5000元即可建造一所小學,他接任主席後設立網站(yunnanprojecthope.com),收錄歷年捐款人名單及建校成果,希望吸引更多人投入協助少數族裔孩子的行列。






