ALPINE ELECTRIC STAFF CAPTURED PICTURES FOR THE VILLAGE TO USE IF NECESSARY. THE COUNCIL WILL CONTACT AT&T AND REQUEST KEITH NELSON, P.E. OF NELSON TANK TO INSPECT CORRECTIONS MADE TO THE WATER TOWER.

HEYMES WILL REVIEW A LEAKING FIRE HYDRANT. THE COUNCIL INSTRUCTED HEYMES TO REPLACE THE HYDRANT IF HE FEELS THAT IT CAN NOT BE REPAIRED.

MOTION BY CLOUS SUPPORTED BY SMITH TO ACCEPT THE MINUTES AS READ CHANGING THE WORD TO ACCESSIBILITIES REGARDING RURAL DEVELOPMENT. ALL IN FAVOR; MOTION CARRIED.

MOTION BY SMITH SUPPORTED BY CLOUS TO ACCEPT THE BILLS AS READ. ALL IN FAVOR; MOTION CARRIED.

WALTON INFORMED THE COUNCIL THAT THE SPRINGVILLE TOWNSHIP BOARD HAS SIGNED A CONTRACT FOR THREE YEARS FOR CHRISTMAS DISPLAY DECORATIONS, THE CONTRACT HAS THE COMPANY BRINGING THE DECORATIONS, PUTTING THEM UP AND TAKING THEM DOWN. MOTION BY CARLSEN SUPPORTED BY BURROUGHS TO PAY FOR HALF OF THE COST EACH YEAR FOR THE CHRISTMAS DECORATION SERVICE. ALL FAVOR; MOTION CARRIED.

MOTION BY CLOUS SUPPORTED BY SMITH TO PLOW THE RIGHT OF WAYS OF THE CHURCHS BUT NOT THEIR SIDEWALKS. ALL IN FAVOR; MOTION CARRIED.

HOWELL IS WORKING WITH THE VILLAGE ATTORNEY TO START CONDEMNATION PROCEEDINGS OF THE DIANE PAYNE PROPERTY.

MOTION BY BESAW SUPPORTED BY SCHAEFER TO ORDER GRAVEL AND PAY WEXFORD COUNTY ROAD COMMISSION TO APPLY THE GRAVEL. ALL IN FAVOR; MOTION CARRIED.

THE COUNCIL WILL CONTACT CONSUMERS REGARDING THE THREE NON-WORKING LIGHTS ON 11 ROAD.

THE COUNCIL AGREED TO LOOK FOR A BETTER FUNDING SOURCE TO PAY ROUGHLY \$250,000.00 FOR THE CULVERT ON 11 ROAD. CLOUS ATTEND A MICHIGAN DEPARTMENT OF TRANSPORTATION TASK FORCE MEETING AND HE DIDN'T LIKE THE RESTRICTIONS OF THE FUNDING.
