MOTION BY CLOUS SUPPORTED BY BESAW TO ACCEPT THE BILLS AS AMENDED. ADDING \$80.09 TO THE WEXFORD COUNTY TREASURER, \$900.00 TO JOHN SZEGDA AND \$300.00 TO WAYNE REITZ. ALL IN FAVOR; MOTION CARRIED.

HOWELL READ AN EMAIL FROM KEITH NELSON, P.E., FEDAWA WAS THE CONTRACTOR THAT THE COUNCIL CHOSE TO PAINT THE TOWER AND HIS WORK LOAD IS FULL AND HE WITHDREW HIS BID, BUT HE COULD PAINT THE TANK IN SEPTEMBER. STANTON WILL CALL HIM AND EXPLAIN THE REBID AND HOPEFULLY HE REBIDS THE SECOND TIME.

MICHAEL FIGLIOMENI, VILLAGE ATTORNEY, INSTRUCTS THE COUNCIL NOT TO SIGN THE CONTRACT, HE ADVISES THE WORDING IS NOT THE SAME AS WHAT HE HAS AGREED TO IN PREVIOUS CORRESPONDENCE. ALSO, HE INSTRUCTED THE COUNCIL NOT TO CASH THE \$100.00 GOOD FAITH CHECK. FIGLIOMENI WOULD LIKE TO REVIEW THE ENGINEERING DRAWINGS FROM AT&T FOR ANY ANTENAS THAT WERE INSTALLED.

MOTION BY BESAW SUPPORTED BY BURROUGHS TO SIGN THE CONTRACT FOR WATER WORK WITH FLEIS AND VANDENBRINK ENGINEERING. ALL IN FAVOR; MOTION CARRIED.

STANTON WILL SEND A COPY OF THE WATER ORDINANCE TO THE VILLAGE ATTORNEY WITH THE REQUESTED CHANGES FOR HIS APPROVAL.

HOWELL READ A QUOTE FROM GREAT LAKES STRIPPING AND SEALING FOR PAINTING A HANDICAP SPACE IN THE VILLAGE DRIVEWAY FOR \$350.00. HOWELL HAS A TEMPLATE, STANTON WILL RESEARCH DIMENSIONS ONLINE AND THE COUNCIL WILL HAVE ABEL DO THE PROJECT. THE PIPE WRAPPING, INSTALLATION, THE BRAIL SIGN, AND THE DOOR HANDLE REPLACEMENT HAS BEEN COMPLETED TO BE COMPLIANT WITH RURAL DEVELOPMENT RESTRICTIONS.

# 2014 Sidewalk Improvements Request for proposal

Concrete shall be a single course of concrete using limestone aggregate with a minimum compressive strength of 3500 pounds per square inch within 28 days of paving and shall have a minimum depth of 4", except that it shall be 6" at all driveways and alleys, and shall be constructed to grade to match adjoining sidewalks or as set by the Village of Mesick. The Village of Mesick will contact "Miss-Dig" prior to construction.

#### Phase I (CURRENT CONTRACT)

Walter St. to Eugene St. south side only.

Remove and dispose of 875 lineal feet of concrete sidewalk.

Earthwork, and prep for sand base and reshape topsoil.

Shape base and place 2" compacted sand base (approx. 27 cu. yd.).

Survey staking.

Concrete for sidewalk, (approx. 54 cu. yd.).

Labor for concrete sidewalk.

## Phase II (FUTURE)

Clark St. to Walter St. both sides, approx. 590', (1180' total).

Remove topsoil, and prep for sand base, (approx. 73 cu. yd.).

Remove 16" pine @ SE. cor. Walter and Henry.

Extend concrete drain culvert.

Compacted in place, fill sand, (raise grade 2' south side only, two locations), (approx. 100 cu. yd.).

Place 2" compacted sand base, (approx. 36 cu. yd.).

Replace topsoil.

Survey staking.

Concrete for sidewalk, (approx. 75 cu. yd.).

Labor for concrete sidewalk.

#### Phase III (FUTURE)

Eugene St. west approx. 530', both sides, (1060' total).

Remove topsoil and prep for sand base, (approx. 60 cu. yd.).

Remove trees -----!!!!!!

Place 2" compacted sand base, (approx. 33 cu. yd.).

Replace topsoil.

Survey staking.

Concrete for sidewalk, (approx. 65 cu. yd.).

Labor for concrete sidewalk.

## Phase IV (CURRENT CONTRACT)

Eugene St., from sidewalk at Mesick Ave. south to Henry St., (west side only), (approx. 550').

Remove and dispose of concrete sidewalk, and prep for sand base, (approx. 132').

Remove 3 small trees and grind stumps @ 116 S. Eugene

Remove portion of two lilac bushes at 224 S. Eugene.

Place 2" compacted sand base, (approx. 17 cu. yd.).

Replace topsoil.

Survey staking.

Concrete for sidewalk, (approx. 31 cu. yd.).

Labor for concrete sidewalk.
