HEYMES GAVE AN UPDATE OF THE WATER BREAK, TREE REMOVAL, SIGNAGE, AND DEQ  
INSPECTION.

MOTION BY CLOUS SUPPORTED BY SMITH TO ACCEPT THE MINUTES AS READ, CHANGING  
TRUOG SPELLING AND ADDING SHOULD NOT. ALL IN FAVOR; MOTION CARRIED.

MOTION BY CARLSEN SUPPORTED BY SCHAEFER TO ACCEPT THE BILLS AS READ. ALL IN FAVOR;  
MOTION CARRIED.

ROAD REPAIRS. CLOUS STATED HE INDICATED TO GABIER THE VILLAGE WOULD REPAIR ROADS
