VILLAGE OF MESICK SEWER RATES AND FEES Resolution No. <u>2021-0/</u>

WHEREAS, the Village adopted Resolution 2017-04 on June 14, 2017. WHEREAS, the Village sewer ordinance authorizes sewer fees by resolution, and

WHEREAS, the Village Council desires to amend Resolution 2017-04 to establish the fees to be charged in connection with Village sewer services consistent with the Village Sewer Ordinance:

NOW, THEREFORE, BE IT RESOLVED, that Resolution 2017-04 is hereby amended to read in its entirety as follows:

Recitals

- A. The Village currently operates a Waste-water collection system to serve the sewer needs of the Village.
- B. The Village has secured a loan through USDA for the maintenance and expansion of its current Wastewater system.
- C. To finance the Project, the Village will sell revenue bonds in accordance with the regulations of USDA requirements.
- D. To provide the revenue needed to repay the bonds (both principal and interest) and to provide the revenue needed to operate, maintain, and repair the Wastewater system, Sewer user fees and charges are necessary.

Resolution

NOW, THEREFORE, BE IT RESOLVED that pursuant to the Village of Mesick's Sewer Ordinance, the Village Council hereby establishes the following rates and fees for Sewer services connected to the Mesick Wastewater system:

SEWER RATES AND FEES

Every user of wastewater removal from the Village of Mesick Wastewater System, regardless of user classification, shall pay to the Village the amounts specified below:

A Usage Fee - \$27.00 per REU (Residential Equivalency Unit).

a.	Every Sewer user who connects to the Village Wastewater system shall pay a connection fee as follows:		
	RESIDENTIAL:	\$3000.00	PER REU
	COMMERCIAL:	\$3000.00	PER REU
	INDUSTRIAL:	\$3000.00	PER REU
b. c. d.	All other costs related to connection shall be paid by the user. Any connection or other repairs to Wastewater service equipment performed by the Village shall be charged at the Village's actual fees for time and materials. Sewer service application fee shall be \$50.00. If the Village does not receive payment for sewer charges as of the due date of the bill, a late fee of 5% of the total water charges shall be imposed and shall be payable to the Village immediately. If a check is presented for payment of water/sewer services and is sent back by the bank as un-cashable, the check writer will be given seven (7) days to make the check good in cash or money order. If the check has not been made good by the seven (7) days, the water/sewer service to the property will be shut off until such time as monies are received to pay the account in full. Any check returned NSF shall be assessed \$25.00 which shall be added to the account. Additionally, the shut off fee will be assessed to the account, on top of the check return fee.
