MOTION BY STRANG SUPPORTED BY ABEL TO ACCEPT THE BILLS AS AMENDED ADDING \$200.00 TO THE CONSUMERS ENERGY BILLING. ALL IN FAVOR; MOTION CARRIED.

THE COUNCIL DISCUSSED ADDING \$500.00 TO THE CREDIT CARD LIMIT AND ALSO RESEARCHING CASH BACK REWARDS.
