### Release of Liability and Indemnification Form

I understand that even regular vaccinations cannot completely guard against illness and disease and that Heartwood Doggie Daycare LLC cannot in any way prevent nor are they responsible for any illness that my dog might contract.

I warrant that my dog(s) is/are suitable to be in the care of Heartwood Doggie Daycare LLC and is/are in good health and have not harmed, show aggression or exhibited any threatening behavior towards any person or any other dog. My dog(s) is obedient and capable of following instructions, I will immediately advise Heartwood Doggie Daycare LLC of any problems with my dog(s) that could affect its behavior, health or suitability for a communal living environment and off-leash activity.

I understand that there are risks inherent in having my dog boarded in environment where the dogs are kept in kennels and are around other dogs and people. #### Animal Medical Power of Attorney

Heartwood Doggie Daycare LLC will make every effort to contact you in the event of a medical emergency of your dog(s). However, if we are unable to reach you, we will need formal authorization to request care of your dog(s) on your behalf. Please review the following Animal Medical Power of Attorney, and if acceptable, please sign below.

I, the undersigned owner, hereby designate Heartwood Doggie Daycare LLC to act as my attorney-in-fact and to act in my name for the emergency medial benefit of my dog upon the terms and conditions outlined below.

- Effectiveness. This Animal Medical Power of Attorney, shall become effective in the case of medical emergency requiring immediate care for my dog during my absence or if deemed necessary to reserve the life or well-being of my dog.
- Powers. By the execution of this Animal Power of Attorney, it is my intention that my attorney-in-fact shall have authority to make all the emergency healthcare decisions for my pet to the same extent I would, including but without limitation, the following; to execute documents; to provide written consent/releases for treatment; to obtain and administer prescribed medications; and to incur reasonable and necessary fees and costs in carrying out the powers and duties under this document that shall be reimbursed by me upon demand by Heartwood Doggie Daycare LLC.

### Assumption of Risk - Release and Indemnification

- Assumption of Risk. I understand that dogs can be extremely unpredictable in behavior and
  while Heartwood Doggie Daycare LLC performs its services, the chance of injury to my dog is
  possible. I assume all risks related to Heartwood Doggie Daycare LLC services to my dog (with
  the exception of gross negligence of Heartwood Doggie Daycare LLC) including but not limited
  to: illness; bodily injury; death; theft; bites; collisions with vehicles; natural disasters; the
  unavailability of emergency medical care, or the negligence or deliberate acts of third parties.
- Release of Liability. I agree not to sue and to release from liability Heartwood Doggie
  Daycare LLC its owners, employees and other persons or entities involved with the services
  offered by Heartwood Doggie Daycare LLC from such actions, claims or demands for injury,
  loss or damage regardless of the cause.

• Indemnification. I understand and acknowledge that dogs can be extremely unpredictable in behavior and may cause damage to third parties for which Heartwood Doggie Daycare LLC could held liable. I agree to bear any and all damages, losses, liabilities, demands and expenses, including legal and profession fees Heartwood Doggie Daycare LLC may incur as a result of any damage caused by my dog(s) and I agree to defend, and hold Heartwood Doggie Daycare LLC harmless from any liability thereon.

It is the intention of the parties to this agreement that the foregoing releases shall be effective as a bar to all actions, fees, damages, losses, claims, liabilities, demands or debts whatsoever, or any nature of kind, known or unknown, suspected or unsuspected, arising out of the performance of Heartwood Doggie Daycare LLC.
