

### Response:

How do people channel emotions or personal experiences into self expression and fashion?

My images consist of a series of portraits showing different personalities dressed in my handmade/designed clothing line. My goal when shooting these images was to capture how being styled in an out of the box aesthetic would make my model feel. Image 2 expresses the struggles of a "gender specific" world and need for representation without retaliation, my models pose and emotion tells the full story. My use of construction/machinery backgrounds in 5, 7, 8, 13, 15 is a play on a lot of the images in my designs an the history behind using pre-loved fabric from sources such as a thrift store. In Image 6 and 12 I used elements of un-reality contrasting with "grunge" street-wear style to make a statement of what positive effects self expression can lead to. Image 11 is a look into what constructing a garment with meaning and thought requires, I digitally sketched and created pattern flats to show detail and documentation of the complexities within the construction. The photos in the background of the sketches are of my sustainable material source, then sketches/full garments in action


