Minutes - Harold Blume Gave Abbreviated Minutes of last meeting to members present.

Mike McCandless made motion to approve, Alisha second. Motion Passed.

Treasury Report - Alisha Cooper gave Treasury Report. Included as attachment.

Harold Blume made motion to approve, Mike McCandless second. Motion Passed.

Harold Blume reintroduced trash discussion in the Stage 2 development area and stated that notice to developers was made and would be made again.

Harold Blume explained the common area – retention pond to non-board members present and indicated that adjacent property owners were misusing that land. He is going to mail adjacent property owners that those areas need vacated, and a cease and desist for dumping.

Kathy McCandelless with construction committee with report of issues about stone, roof, and house colors. Elevation also discussed (Max elevation 32" to back of curb, city allowing additional 12" to 44.

Beth Hanson talked about grade behind her house and was told by Kathy McCandeless to stay on builder to ensure it's where she wants.

Harold Blume talked about updating bylaws and covenants to be approved at next annual meeting, and talked about the covenant sign installed. Looks good.

Mowing Bids -

Three companies entertained bids. SS, Fox Landscaping, 4 Brothers.

Harold Blume took each around to show boundaries and to ensure work done in manner to keep drainage flowing. Discussed ensuring silt barriers are being maintained during construction by developers.

Fox - \$350 every 2 weeks or \$500 monthly 4 Brothers - \$450 every mow SS Services - \$324 per mowing \$55/hour extra – Once a month (Current Bid Holder)

Harold move to accept SS Service Bid.

Adam Volcek brought up that contract should be for \$324 per mowing at either discression and weed eat along property line at \$55/hour at our discression.

Beth Hanson brought up 'wild' nature and concern with poison ivy and wild animals.

Mike McCandless second motion to approve. Approved unanimously

## Budget for 2018 -

With current estimates of \$500 for general expenses (office supplies, fees) and \$3500 for mowing.

Mike McCandless made motion to keep assessments at \$35. Alisha Cooper second motion. Motion passed unanimously.
