1. GCSS-Army System Support

- Work order lifecycle management (open, update, close, fault tracking, technical status changes).
- Material accountability: order, track, consume, and reconcile repair parts.
- Supply chain integration: manage purchase requisitions, purchase orders, and “Parts Received Not Installed” lists.
- Dispatch operations: open and close dispatches IAW unit’s SOP. (consume fuel, oil and miles)
- Manage the Equipment Status Reports (ESRs) for accurate readiness visibility.
- Shop management: establish maintenance shops and assign mechanics to Work Centers (91B, 91C, 91F, etc.).
- Systems to systems management: Example; attach truck to weapon system (ERC P) on GCSS Army IAW the Army’s Basic of Issue Plan (BOIP)

2. Technical Logistics & Compliance Support

- Monitor SOUMs, GPMs, MAMs, and MWOs for compliance and execution.
- Access and provide Technical Manuals (TMs) for troubleshooting and maintenance accuracy.
- Track requisitions using document numbers and consolidated parts trackers.
- Oversee Army Oil Analysis Program (AOAP) compliance to extend equipment lifecycle.

3. Class IX Supply & Material Management

- Maintain and reconcile Class IX records; process turn-ins and coordinate SSA runs.
- Execute goods receipts/issues (PGR/PGI), material transfers, and batch code updates.
- Track inbound deliveries (IBD), manage bench stock reservations, and monitor MAT-SIT property accountability.
- Conduct walk-throughs to validate parts handling, storage, and documentation compliance.

4. Data Analytics & Power BI Support

- Develop and maintain dashboards for readiness, maintenance trends, and supply visibility.
- Share cross-organizational visualizations for data-driven decision-making i.e. Teams
- Build unit Power BI Apps with automated daily refreshes for real-time accuracy.
- Create automated triggers and alerts for overdue services, parts shortages, and supply chain bottlenecks.

5. Compliance & Administrative Reporting

- Maintain daily key logs (Key Control) for motor pool and equipment access.
- Track and report overdue dispatches daily for compliance and readiness visibility.
- Develop and manage motor pool memorandums IAW the Command Maintenance Discipline Program (CMDP).
- Provide weekly direct/indirect man-hour reports IAW AR 750-1 for workload tracking.
- Manage the unit’s TMDE Program i.e, Coordinate turn-ins, pick-ups; ensure all diagnostic equipment remains fully mission-capable; track readiness status in GCSS-Army/AESIP
