THE REMOVAL OF ANY VEHICLE OR VESSEL FROM THE ABOVE NAMED PROPERTY WILL BE DONE IN ACCORDANCE WITH THE FLORIDA STATE STATUTE **715.07** "When a person improperly causes a vehicle or vessel to be removed, such person shall be liable to the owner or lessee of the vehicle or vessel for the cost of removal, transportation, and storage; any damages resulting from the removal, transportation, or storage of the vehicle or vessel; attorney's fees; and court costs."
