Next Gathering: Wednesday, April 2nd, 6:30 pm



See you then!














The American Legion was chartered and incorporated by Congress in 1919 as a patriotic veterans organization devoted to mutual helpfulness.

Christopher Celiz to get Memorial Sculpture

Medal of Honor recipient Sgt. Christopher A. Celiz will be memorialized with a sculpture in Summerville. On Monday, Jan. 6, the town finance committee voted to match funds with Dorchester County – not to exceed \$15,000 – as a tribute to Celiz's sacrifice.



Christopher Celiz (second from left) pictured as a sophomore cadet at The Citadel.


Celiz, who was from Summerville, died during his fifth deployment. According to army.mil, Celiz used his body to shield his team from enemy fire in Afghanistan. He is survived by his wife, Katie, and their daughter. "Not many people are willing to make that kind of sacrifice, especially now, and I think it's important for people to see freedom is really not free," said town council member Bob Jackson, who helped secure funding for the sculpture. "That sounds a little cliche, but it's the truth." of Honor posthumously. The sculpture will appear in the relocated veterans monument garden when 500 North Main is redeveloped. It will feature Celiz with his wife and daughter behind him, paying

tribute to the whole family. Jackson estimated the project will be completed in one or two years. Sculptor Susie Chisholm is the artist responsible for memorializing Celiz, and she previously created a life-sized bronze statue of Coach John McKissick for Summerville High School. Sculpture in the South is also sponsoring the project. "He was a man with a family, not

Nurse 2nd Lt. Ernestine Koranda

2nd Lieutenant Ernestine May "Carmen" Koranda was born 30 May 1912 in Lesterville, South Dakota. She was the daughter of Joseph Koranda and Matilda Winter. A graduate of the Ancker Hospital School of Nursing in St. Paul, Minnesota, Koranda enlisted in the Army Nurses Corps in 1942. In 1943, she was serving at the Army's 12th Station Hospital in Townsville, Queensland, Australia. On 19 December 1943 she was a passenger aboard the C-47A #43-30742 ("Hoosier Traveler" of the 22nd Troop Carrier Squadron) when they departed from Townsville-Garbutt Airfield in Australia during a ferry flight to Brisbane-Archerfield Airport in Queensland. The aircraft exploded and disintegrated in the air crashing at Canal Creek about 30 miles NW of Rockhampton, Queensland. All 31 aboard were killed, including three nurses. This was the second worst crash in Australian aviation history. Sadly, Koranda was on her way to Sydney to wed her fiancee. "Carmen," as her friends playfully called her, was 26 years old. She is buried in Wadena Cemetery, Wadena, Minnesota

Koranda was honored by the U.S. Army who bestowed her name on the former freighter Dorothy Luckenbach. It became a Hospital Ship.






Photo: United States Army Nurse Corps Lt. Ernestine Koranda giving injection to St. James Visaki of Burlington, NJ, 1943



The Veterans Affairs office assists all ex-service personnel with financial compensation claims including but not limited to:

- Hospitalization
- Training
- Insurance Benefits

These services are extended to eligible dependents, including parents, widows, children and orphans of ex-service personnel.

If you need support for a specific mental health problem - or if you're having problems sleeping, controlling your anger, or readjusting to civilian life - you are not alone. You don't need to be enrolled in VA health care to get care. To access free VA mental health services right away:

- Call or walk-in to any VA Medical Center anytime, day or night
- Call or walk-in to any Vet Center during clinic hours

If you have questions about enrolling in VA health care, please contact the VA via phone at 1-877-222-VETS (1-877-222-8387) Monday - Friday, 8:00 AM to 8:00 PM EST. Veterans with hearing loss are asked to use the TTY phone number 1-800-877-8339.

Newly separated service members can expect three calls from qualified VA Solid Start representatives over the first year of separation. VA will attempt to contact you several times around 90, 180 and 365 days post-separation, so make sure your contact information is up to date in eBenefits.

VA Solid Start representatives will not ask you for financial information and will only discuss topics you are comfortable with. Remember that phone scammers often target Veterans, so always be vigilant and protect your financial information when talking to someone you don't know over the phone.
