I wanted to follow up with you regarding Condition #4 you provided for the Vail Crossings Staff Report.

Condition 4 reads, “*Prior to development plan approval, written proof of coordination with the Arizona Department of Transportation (ADOT) is required regarding any traffic impacts to their roadway system.*”

Given the site’s distance from I-10 and that the site does not utilize an ADOT frontage road for access, would it be possible to remove this statement from the staff report?
