Stallion Service Contract

To the Stallion: **Grande Sovereign, Oldenburg RSPI #33-93792-98** for the **2021** season at a breeding service fee of \$800 includes first collection (shipping Must be paid at the time of collection to Nandi Vet Associates (717)235-3798, IF SHIPPING SEMEN all fees as a whole are due and payable before the semen is shipped. Once viable semen has been shipped to the Mare owner or his/her agent, the stud fee is non-refundable. Collections are done on Mondays Wednesdays and Fridays. Mare owner must give 24 hour notice for ordering semen!! On farm mare care available at the following rates:

Barren Mares: \$400 per month or \$15 per day for mare care Field Board also available for \$275 a month

Mare with foal: _____\$20_____/day (Date Mare foaled: _____)

1. The Mare Owner agrees that the Mare offered for breeding is in sound breeding condition and free from infection and disease.
2. When artificial insemination and/or transported semen is used, a current negative culture is recommended but the decision to culture a mare or not is left to the discretion of the attending veterinarian. **All costs associated with Artificial Insemination (Excluding first collection) are to be assumed by the Mare Owner. A second collection is available for \$215. At that time mare owner must present a copy of a clean culture from their vet. Mare owner must give AT LEAST 24 hour notice for ordering semen, collection days are Monday .**
3. In the case of any illness, condition, disease or injury, the Mare Owner agrees that a suitable course of treatment may be undertaken, in consultation with the Mare Owner, by a qualified veterinarian at the Mare Owner's request.
4. Diligent effort will be made to settle the mare, however, if for any reason she does not settle, the Stallion Owner (or his/her agent) will not be held liable.
5. The Stallion Owner guarantees a live foal, defined as one that stands and nurses the Mare, a substitute mare, or other nursing apparatus, within one week of birth. If a live foal does not result with this mating, the Mare Owner is entitled to a return privilege in the next breeding season, for the same Mare or a substitute approved by the Stallion Owner.
6. It is understood that the Stallion Owner, his/her employees, veterinarians, and agents shall not be liable for any injury, escape, or death of any horse presented to the Stallion for breeding. The Mare Owner agrees to hold the Stallion Owner his/her employees, veterinarians, and agents harmless for any damage or injury to any person, horse or property caused in whole or in part directly or indirectly by the Mare Owner's Mare and/or her foal.

7. It is agreed that if the mare dies or becomes unfit for breeding during the breeding season, the Mare Owner may substitute another mare to breed to the Stallion; subject to the breeding requirements and approval of the Stallion Owner.
8. If the Mare is sold or this breeding is not used by the Mare Owner within the current year and/or the next year's breeding season, this contract is non-transferable.
9. When this contract is signed by both parties, it will then be a binding contract on both parties, subject to the above terms and conditions
