1. **Registration & fees:** Registration fee is **\$20.00** and is billed on an annual basis. Terms and conditions apply. The fee for learning dance at SKDA will be charged based on the batches (Steps, Jathees & Items) per month. All fees are due within the first weeks of the month, after which a late fine of \$10.00 will apply. Payments should be made to SKDA. Fees are subject to change and are non-refundable. This form must be filled and signed before joining/starting at SKDA.
2. **Guide lines for Parents:** As per SKDA management, parents are not allowed inside the class premises to avoid the students' distractions and inconvenience. Students carrying cell phones to the class is strictly prohibited. Any clarifications regarding the class will be answered via emails. Pick and drop should be on time and if there is any delay for pick up please text us. Your child will be sitting inside the class room while waiting for pick up. Please ensure waiting time doesn't exceed more than 5-6 minutes. Any violations in this regard will be nominally charged and will be billed to next tuition cycle. All students should be purchase audio from SKDA before starting the item for practicing outside the class hours. The audio is copy righted and should not be shared, distributed or uploaded to social media platforms or any other online platforms for downloads.
3. **Duration of Kuchipudi Dance:** SKDA planning to finish the classes **Steps 1 year, Jathees 1 year & Items 4 years** however duration will be change based on individual student performance and effort.
4. **Shows & events:** SKDA students get to perform at various shows and charity events throughout the year. Students must be available for extra classes as and when such events are held. These classes are free and take place only to ensure that students get enough practice and exhibit the best performance while representing SKDA.
5. **Dress code & conduct:** Students need to be in proper dance attire while in the class. Acceptable attires are T-Shirts and Track Pants for boys and Salwar Kameez and Kurtis for girls. Dupatta is mandatory. Jeans, shorts, skirts and short clothes are strictly forbidden, and students will not be

allowed if there are any dress code violations. Students must maintain proper conduct and respect the faculty and facilities. Abusive language, racism and misconduct will not be tolerated. This also applies to parents of the students while at the facility. Any student/parent resorting to such behavior will result in the student being expelled from SKDA.

6. **Cancellations & holidays:** SKDA will not honor any last-minute cancellations. Classes will not be held during the Diwali & New Year's (Dec24 - Jan2). **No makeup** classes will be held for this duration.
7. **Media assets:** Often at SKDA, parents/students will record dance sessions for future reference and practice. By signing this form, you are agreeing to your child or yourself being recorded in a group along with others. All such media assets cannot be re-distributed or displayed on public sites such as You Tube, without the consent of SKDA. SKDA and its management will not be held responsible for any form of misuse of such property.
8. **Liability & release:** At SKDA, students are physically involved in learning dances. By signing this form, you are acknowledging the possible injury risks involved due to physical activities and hereby release SKDA and its instructors from any claims and/or damages, including medical or hospital bills that may arise from you/your child's participation in any dance activity at SKDA.
9. **Dance theory & Natyashastra exams:** All students are expected to be well versed with dance theory. SKDA prepares students for theory exams which will be conducted by an outside examiner on a yearly basis. Theory classes will be held during one class every month for 30 minutes (except during show deadlines). Theory and dance skills will be used to decide if the student can be promoted to the next level or continue in the same level. The theory examination is mandatory for every student. SKDA strives to create well rounded students who can study art while practicing it.
10. **Complaints or concerns:** Any grievance, complaints or concerns must be addressed only to the SKDA management over the phone to be solved through arbitration. After class discussions or group email threads will not be entertained.
11. **Annual show & performance fees:** An annual show will be held every year, showcasing talents of the SKDA student body. This show is mandatory for all students to take part. A performance fee will apply for each student.
12. **Suggestions:** At SKDA, we are always open for suggestions and constructive criticism. Please reach out to class teacher or management for suggestions over the email.
