Terms and Conditions

Carefully review the below terms and conditions prior to facility use. Please initial each section and sign at the bottom of the form to indicate your agreement and understanding. This form is required for all clients, members, and supervising adult guests.

Monthly Membership Structure

Our purpose at Hydro Air Treadmill Lab ("HATL") is to provide an unparalleled exclusive fitness and wellness experience using gold standard equipment to enhance longevity and quality of life by fostering low-impact movement, decreased inflammation, and improved strength training; all while experiencing more rapid recovery and decreased pain. To accomplish this, we may offer day passes, packages, and exclusive monthly memberships, which grant access to HATL equipment and services. Full access membership includes the following:

1. Keyed access to the locked front door. Extended hours granted upon approval (contact HATL for specific times).
2. *Unlimited scheduled treadmill sessions.
3. *Unlimited scheduled cryotherapy sessions.
4. *Unlimited scheduled red light therapy session.
5. Full access to all other amenities including plunge, compression, Fit3D Body Scanner, bikes, massage, stretch, and strength equipment as available.

HATL offers two (2) Monthly Memberships, including the VIP and Essential Monthly Membership. Both memberships include all the above. However, the Essential Monthly Membership is restricted to 6 lab visits per month (instead of unlimited visits). A visit is when a member arrives at the facility (usually scanning their credentials at the front entrance), uses equipment, and leaves the facility. Multiple visits in one day may count towards that total monthly visit count. While on site, all members are permitted to use the equipment as often as desired per the usage and safety limitations on each visit.

Monthly membership is available to individuals age thirteen (13) and up. Minors under eighteen (18) must obtain parent/guardian approval at sign up and remain at or near the premises for each visit. Minors must also be accompanied by a parent/legal guardian for use of all equipment.

No physical therapy (PT) services are offered by HATL. Any services or recommendations given by other individuals or entities within the facility (such as Hydro Air Physical Therapy, PLLC) are at the sole discretion and risk of that entity and do not represent or hold claim on HATL.

Exclusive memberships are charged as recurring monthly. All purchases are final and non-refundable. HATL reserves the right to terminate or restrict membership at its sole discretion. HATL may review and/or update and otherwise modify membership terms/conditions, pricing and fees and, if so, will publish on the website and appointment booking system to indicate the latest version of our policies. If this is the case, the member will be

notified and given the option to accept terms or cancel membership prior to renewal. Upon renewal at monthly recurring billing cycle, the updated terms/conditions and pricing will apply, and prior membership terms/conditions will no longer continue.

HATL cannot guarantee the function and availability of equipment items and may be subject to cleaning, repairs, marketing or paid events, and other unforeseen or scheduled blocks. Equipment use and services may also be sold by HATL on a standalone ("À la carte") basis to members or non-members with pricing and terms determined upon sale. Additionally, HATL may offer single-day passes or other products/services at its discretion, which may affect facility occupancy and equipment availability during standard hours.

**These equipment items cannot be used without scheduling online first. All other supplemental (non-scheduled) equipment may be used as often as available while the member is on site. Please be considerate of other members while using unscheduled equipment and limit your time when other members are waiting to use it. Follow all safety guidelines and usage limits.*

Discounts and Promotions

HATL may offer limited discounts and promotions from time to time for marketing purposes. These discounts may apply to individual products, services, packages, or memberships with terms and limits determined at time of sale. HATL reserves the right to remove or alter any discount at any time. HATL will give advanced notice for alteration or removal of any discount applied towards recurring monthly memberships, prior to the next recurring charge.

HATL may also offer a 1-week (or other duration) membership free trial period. If this is the case, the client agrees to provide their credit card information and be automatically enrolled in the VIP monthly membership at expiration of the free trial period, to the recurring monthly billing schedule at the full cost of VIP membership unless otherwise agreed on. If the member desires to cancel their free trial before the first billing charge takes place, they must notify HATL in writing according to the terms below.

Membership Cancellation and Refund Policy

Memberships (including free trial periods) may be canceled at any time. In the event of cancellation, your recurring monthly charge will be turned off and you will not be billed at the next billing cycle. The membership will officially expire at the end of the current (paid) billing cycle. Membership benefits may be enjoyed until that time. To cancel your membership, you must contact HATL at least five (5) days before your next scheduled dues payment to avoid additional payment. Cancellation requests made after this time cannot be guaranteed to take effect prior to the next billing cycle. These cancellation requests must be sent in writing to memberships@hydroairlab.com, contact@hydroairlab.com, or may occur in person with a staff member on site where the client will obtain written/printed confirmation of the cancellation. VERBAL NOTIFICATION FOR CANCELLATION IS NOT ACCEPTED. We do not offer refunds for memberships or services rendered.

Session Late Arrivals, No-Shows, Cancellation, and Reschedules

All members should arrive at least 10 minutes prior to scheduled sessions and appointments to allow enough time to change, rinse off, warm up, and otherwise prepare for your scheduled activity. Late arrivals are not granted a time extension of their scheduled session.

All purchases are final and non-refundable. However, exceptions may be considered in extenuating circumstances. If cancellation or reschedule of your session is needed, you must call or contact HATL in writing at least 24 hours prior to your scheduled session. Cancellations and reschedules may not be considered within 24 hours of scheduled session. Adjustments and refunds are not guaranteed and are subject to the sole discretion of HATL.

Members with unlimited scheduling will have the ability to reschedule or cancel prior to their session using the provided online software. However, excessive cancellations or no-shows may result in the member(s) having their ability to schedule appointments restricted or suspended, at the discretion of HATL.

Dress Code

All members and guests shall be appropriately clothed for all activities within the facility. In all public areas, men and women must wear adequate covering of all private body parts. Please use private dressing rooms for changing. The red light, 3d scanner, cryo, and restrooms may also be used for brief changes in wardrobe. It is not appropriate to undress or change in the plunge area or within the rinse/shower room due to limited privacy. Swimsuits may be worn while using water equipment. No speedos or revealing bikinis may be worn in the main area. Please use provided robes as needed while walking through public areas. Close toed shoes must be worn while lifting or using resistance equipment. HATL reserves the right to request appropriate clothing adjustments at any time. Please consult all posted signs for proper clothing and dress before using any equipment. If you have any questions, please speak with a staff member before use.

Keyed and extended-hours access

Our doors are always locked (except on occasion while staff on site) to maintain a safe and exclusive atmosphere. Upon signing up for an active membership, the member will be given the option to receive either a physical key fob or an email containing app (Brivo) access for the security locks on the front door. This will grant the member the ability to unlock the front door and enter the lab during and after operation hours. The facility may not always be staffed, but the key will allow access and the member may use facilities per safety agreements terms, conditions, and waivers. **The member agrees NOT to attempt initial use of any equipment item without first receiving instruction and assistance from a staff member or without signing the associated waivers.**

To use HATL facilities during extended hours, I confirm that I have reviewed the operation and safety procedures with a staff member for each equipment item listed below:

- Hydro treadmills
- Air treadmills
- Plunges (hot and cold)
- Cryotherapy chamber
- Red Light Therapy (RLT) Table
- Massage equipment (including compression)

If I am unsure about how to use or whether I should use any item at HATL, I will ask a staff member or call the posted numbers for extended hours guidance. In case of medical or other emergency, I agree to call emergency services or 911.

I further understand and agree to the following:

1. I have read and understand all equipment operation and safety materials and agree to follow all safety guidelines and observe all warnings and precautions.
2. I will not use any equipment item without receiving staff orientation and a review of operation and safety instructions prior to first-time use.
3. I have located and know where to find all emergency exits, fire alarms, AED, and fire extinguishers.
4. I have obtained staff approval for each item in the "Facility competency sign-off" sheet (above), indicating I understand safe operation and use associated with each machine.
5. I agree to be supervised by another competent and consenting adult for use of all water equipment.
6. I agree that I am fully responsible for all damages, neglect, or injury either directly or indirectly caused by their actions or the actions of accompanying guests, or other persons on site and will not hold HATL liable to such claims.
7. All minors (under 18) must be accompanied by their parent/legal guardian when HATL staff are not present. Children under the age of thirteen (13) are not permitted to use HATL facilities.

HATL facilities provide storage bins and lockers for members' use while on site. Please do not leave or store any personal items overnight. HATL is not responsible for any missing personal items either due to loss, damage, or theft. While the security cameras may be used to help determine what may have occurred, their function and operability cannot be guaranteed. Please do not attempt to move or touch the property or items of other individuals without their prior consent.

I agree to the terms and conditions for keyed and extended hours access to HATL facilities. **I agree that my access may be limited or revoked at any time and for any reason at the sole discretion of HATL.**

Exclusive members may bring up to 2 guests (13 or older) to accompany them (to provide supervision, etc). However, no guest may use equipment for which they are not scheduled, including any of the supplemental (non-scheduled) equipment. Those are reserved for members only. All guests must pay for usage of scheduled equipment, and reserve using their own profile through our website, and sign all required waivers and forms prior to use. **I assume responsibility for damage or neglect on their behalf until such time as they sign up for their own exclusive membership.** In the event of any medical or other emergency which affects either myself or any of the guests I bring to HATL, I agree that I will not hold HATL liable for any claims arising from such events. damage/theft that occurs if I or my guest leaves doors propped open or does not ensure doors adequately shut after finishing. I agree to treat this equipment and facility as if it were mine and take reasonable care and attention to items that may be out of place or dirty. I recognize that this facility has security cameras which always record actions/events and may be viewed by staff as needed.

Group Events

HATL will occasionally host group events within the facility which may greatly affect member access to the facility and equipment. Members will still be welcome to use the facility but their access may be limited. These events will typically be limited to 3 hours or less and up to once daily. If this is the case, HATL will give advanced notice to each member via text or email and will block all scheduled equipment times on the scheduling software. We will also post a notice on the door letting users know about the upcoming event so that members can adjust schedules accordingly. Following each event HATL will ensure that the facility is returned to optimal condition.

Cleaning policies/procedures

Clients may be required to complete a health waiver and agreement prior to using our equipment which will help screen for contagious and communicable diseases, including TB, MRSA, flu and COVID. Please do not visit HATL facilities if you suspect you may have a contagious, transmissible, or otherwise infectious illness.

Courtesy disinfecting wipes and hand sanitizer stations are located throughout the facility. Reminders are posted which encourage all to help maintain a clean and tidy facility.

Each water machine has a dedicated filter pump which circulates water regularly. Filters are replaced per recommended guidelines. Bromine levels are maintained according to recommended guidelines. Additionally, HATL will completely replace the water in each machine regularly. To help maintain the water cleanliness, free from debris and lint, all customers must rinse off immediately before using water equipment.

On occasion, HATL may close an equipment item for repairs, regular cleaning, and/or maintenance. If this is the case, HATL will attempt to give as much advanced notice as possible, to allow members to make needed schedule adjustments. During the cleaning or maintenance process, the equipment schedule will be blocked. Once finished, the schedule will open up again and the scheduling process will resume as normal.

Smoking Policy

Smoking in any form is prohibited inside or within 20 feet of the facility.

Animal Policy

Animals are not permitted within the facility except where the animal is trained to assist the owner with a certain task or disability. The handler is responsible for caring for and supervising the service animal, which includes toileting, feeding, grooming, and veterinary care. HATL reserves the right to ask the handler to remove any animal which is not housebroken, or which provides a risk to the safety of others present or is out of the handler's control. Any damage or cleaning fees incurred to facilities, equipment, or property by any animal is the sole responsibility of the handler or owner.
