Crazy way to start the newsletter, but appropriate considering what Jim Garboden, Mike Donnelly, and I experienced a couple of weeks ago,

The three of us attended the Ron Fellows Corvette High Performance driving school in Pahrump, Nevada, at the Spring Mountain Racing Facility and Resort.

I need to say right now that I did not graduate. I'm sure you all know I have been suffering from severe back issues for quite a while, I knew going in it would take a lot for me to complete the 2 day school. I did finish the first day, but I started having back spasms and just didn't want to put anybody in a dangerous situation.

But, what an experience that 1st day was. I know all three of us watched Youtube videos of what to expect. But let me tell you that what you see in a video DOES NOT do justice to the real deal!!!

First the terminology. The absolutely superb instructor staff was fond of saying things like "when I say stand on the brakes, I mean STAND on the brakes", or when I say "GO GO GO" I mean just that, or "hey, you aren't driving your Corvette, you're driving ours. So DRIVE it as hard as you can." I can truthfully say I will NEVER drive my car like I drove their car. Most of the first day exercises centered on shifting and braking, with a lot of finding out what happens when you don't do it right. And although each of the 3 of us did a (one or more) spinout we did it on purpose.....or not.

Did I mention concentration? Concentration was the name of the game with the exercises. Let me tell you how hard I was concentrating during one session. The goal was to quickly get up to speed (70) then shift at the markers they had laid out. So during one of my runs I found myself concentrating on my moves so hard that when I was supposed to shut it down, I sort of missed that part. I only realized it when the instructor said "Sir, where are you going?" Embarrassing? Downright humiliating is what it was.

Bottom line is we all had a spectacular time. Spring Mountain was just a very classy place. Even if I didn't graduate.

“If everything seems under control, you’re just not going fast enough” - Mario Andretti

That may be true for a professional race car driver like Mario Andretti, but at Ron Fellow’s Spring Mountain Performance Driving School, control is learned in conjunction with speed.

As several other Cascade members before us have experienced, the Corvette Owner’s School teaches students about the intricacies of the latest Corvette while learning the basics of performance driving. The Corvette Owner’s School is sponsored by General Motors in conjunction with Spring Mountain. Owners become eligible to participate by buying a new, never before registered Corvette. The new owner pays \$1000 and GM pays the remaining \$2695 for the two-day instruction, one night lodging at the Spring Mountain Resort condos and breakfast & lunch for students and guests.

Three Cascade couples were able to reserve at Spring Mountain this past March 11 - 12. Stiles, Donnelly & Garboden traveled to Pahrump, NV (one hour west of Las Vegas) to begin the adventure. Each day’s instruction starts at 8:00 am and ends at 4:00 pm. The amount of information has been likened to “trying to drink from a fire hose”.

The first day is a combination of classroom sessions and in-car exercises designed to teach the student some basics that we take for granted - braking and steering. We all know that our Corvettes are equipped with ABS brakes (Anti-Lock Brake System), but how many of us have actually FELT the ABS in action. We first learned how to “panic stop”, then learned how to steer ourselves out of trouble while panic stopping. We then moved to a wet skidpad for the figure-8 exercise. With the Corvette in Track mode, we attempted to negotiate a very tight figure-8. Everybody spun out at least once. The instructor then put your Corvette in Weather mode, and no matter how hard we tried, we could not make the Corvette spin on a wet surface. Next we moved to a very short semi-circular track where we began learning the basics of cornering. After lunch we moved to the actual track we would be using for the remainder of the session. We did one exercise in which we accelerated down the straight, then brake hard and down-shift. Turn around and do it again in the opposite direction. Repeat until you are comfortable with braking hard, then easing up on the brake and downshifting. *FINALLY*, we get to do laps on the track... at 35-45 mph to learn the layout, the braking zones, turn-in marker, how to clip the apex, unwind and accelerate. At the last classroom session of the day we are warned to get a good night’s sleep, don’t over-eat or over-drink because things are going to ramp up and get very intense the next day. That night all six of us went to Symphony Restaurant, the #1 restaurant in Pahrump for a *fabulous* meal. Jim G was so amped about the upcoming day that he could not finish his steak!

The second day was a whirlwind! 20-25 minute classroom session, 5-10 minute break, 30 minutes of track time. Learn something new about the car’s functions, then go out and put that function to use on the track. All the while, the speeds increased. After lunch, just as the student’s were beginning to feel pretty good about themselves and their abilities, we got to be the passenger (in our assigned Corvette) with one of the instructors. The only female instructor, Jenny, made a mockery of my lap times. My helmet was smacking the window and my ribs were bruised by the console - I finally had to grab the door handle and the “chicken bar” for support. But from that experience, we learned what it was really about to drive fast while still in total control. I learned where and when to brake, when to “balance” the car through corners and where to accelerate. Unfortunately, some of our classmates experienced “car-sick” symptoms during the ride-along and could not complete the rest of the afternoon.

The next few track sessions became more and more intense. I felt that the next to last session on track may have been my best. I felt it was my fastest laps, I felt in control and was very happy with my speeds. I actually thought I was “pushing” the instructor at times. (Okay, let’s be totally honest for a moment - those instructors, driving Camaros, could drive away from us and make us look like fools any time they wanted) My last track session could have been my worst. For a split second, I lost focus coming into turn 1 at 113 mph. I remember the speed because I was looking at the HUD when I should have been planning my braking, down-shift and turn-in. As a result I braked a split second late and found myself in the middle of the turn instead of on the right apex. Had I accelerated like usual I would have been out in the rocks, which would have been **very expensive!** Spring Mountain doesn’t like you breaking their Corvettes. At the end of that session was when I realized I was drained, mentally and physically.

Let me tell you about the instructors - these men and women are great drivers and great educators. They all have racing backgrounds and can read what each student is capable of doing. Above all, they are patient. They do this 2-3 time a week, yet remain pleasant and patient with every student personality we can imagine.

After attending Spring Mountain, I have a newfound appreciation toward this incredible C7 Corvette. I also feel a greater admiration for the people who race these (or any) cars professionally. The level of physical fitness and mental focus required must be amazing.

If you are lucky enough to be able to buy a new Corvette, Ron Fellow’s Spring Mountain is a must-do.



Mid Engine Monthly Update (by John Elegant)

A lot is happening in the C8 world, starting with this new to us interior C8 picture. For those concerned that it appears the interior is too small, if you can fit in the C7, you will be just fine in the C8.



Notice the “Stingray” emblem in the shot on the “waterfall.” Might the 2020 mid engine (ME) be again called a Stingray? If so does that confirm that the C7 is over at the end of this production year — for having two distinctly different Stingray models, an front engine and a mid engine version, seems to me to be an exercise in “Corvette confusion creation.” Is that a Stingray tail design in the seat back?

We also learned that the C8’s rear turn signals are sequential, with at least a three LED progressively-narrowing-band to the turning side. Also, the C8’s door mirrors have echoing turn signals.
