The South Willamette Valley Honor Flight Story By Mike Pungercar

"I am a Baby Boomer. My dad, Frank Pungercar, Jr. was a World War II veteran. Dad served with the Eighth Air Force, 91st Bomb Group, 323rd Squadron as a radio operator on a B-17 Flying Fortress. He flew on 30 combat missions, all over targets in Germany. Like the majority of the 16.1 million veterans who served in World War II, dad never talked much about his time in the service. When he was 79, we went on a fishing trip into northern Michigan and on the drive back to his house in Sheboygan, Wisconsin, he began sharing story after story of his experiences in the Army Air Corp. He seldom referred to his service branch as the Air Force, but that's another story. I asked dad to tape his stories for me as no one in the family knew what he did during that war. I promised him I would share his stories with everyone in the family so they would always remember the sacrifices he had made during that period in his life. About six months after our fishing trip, a cassette tape arrived in the mail at my Oregon home, "My Years in the Army Air Corp, April 1943 – Oct. 1945, by Frank Pungercar".

Dad passed away just a couple of months shy of his 83rd birthday. Several months after his passing, I transcribed his tape, and found that I had many questions I wanted to ask him, but it was too late. I began what turned into a three-year journey to learn what he had experienced back in the 1940s flying in combat on an unheated, unpressurized plane, flying at 25,000 feet while on oxygen in temperatures as low as 60 degrees below zero. As I traveled doing my research work, I met other veterans of the Eighth Air Force who shared their stories with me. In 2011, the 12-page transcription of dad's tape, as well as the stories of a number of the veterans I had met, was included in a book I wrote about the 'The Air War over Europe' During World War II. My book is titled "The Promise Kept".

One of the veterans I met during my travels asked me if I had heard about the Honor Flight program. He went on to share his Honor Flight experience with me. The local Honor Flight flew him from Milwaukee, Wisconsin to Washington, D.C. where he visited the various Memorials on the National Mall and the surrounding area. There were over 100 World War II veterans on his Honor Flight. He told me that no one had ever thanked him for serving his country, and that his Honor Flight was the trip of a lifetime. I learned that the Honor Flight program transported these veterans on their Honor Flight at no cost to the veteran. When I heard the emotion in his voice and saw the expression in his eyes as he shared his experience, I knew that I wanted to check into the Honor Flight Program.

After the release of "The Promise Kept" in late 2011, my wife encouraged me to look into the Honor Flight program. We lived in Sunriver, Oregon at that time, and I met Dick Tobiason, President of the Bend Heroes Foundation, the organization that coordinated the Honor Flight of Eastern Oregon. Dick supplied me with background information he used to organize their Honor Flight hub which covered all of Oregon east of the Cascade Mountains. He had me serve as his assistant and trained me to be a leader on their June 2012 Honor Flight. I was able to make contact and meet with Gail Yakopatz from Grants Pass, Oregon who had started the Honor Flight program in Oregon and was President of Honor Flight of Oregon. She was covering all of the counties in Oregon west of the Cascade Mountain range. I told her I would assist her with fund raising and doing presentations about the Honor Flight program, and would cover four counties within her area of the state. We had moved back to Springfield, Oregon in Lane County, and I agreed to cover Lane and the three adjacent counties boarding Lane County to the north: Benton, Linn, and Lincoln counties. Gail encouraged me to organize my own Honor Flight hub. I made contact with the Honor Flight Network headquarters in Springfield, Ohio and was provided with the forms and information to organize an Honor Flight hub. In March of 2012, the charter was granted for the formation of South Willamette Valley Honor Flight of which I became the Director. We are a non-profit organization, and the money we raise through doing presentations and fund raisers goes to the cost of getting the veterans on their Honor Flight. The Honor Flight is an allexpense paid trip for our veterans. Volunteers who travel with the veterans, and all those in leadership positions, pay their own expenses to go on the Honor Flight.

We organized our first Honor Flight in October of 2012 and took 52 World War II veterans to D.C. Gail went on this Honor Flight as my assistant. We gathered at a hotel in Portland, OR on Thursday afternoon for the welcoming, opening dinner, and orientation. We traveled by commercial airlines on Friday to Washington, D.C. and checked into another hotel for dinner and a briefing on the next day's activities. On Saturday morning we visited the World War II Memorial. During a photo opportunity in front of the Wall of Stars which has 4,048 gold stars representing the 400,480 U.S. troops who were killed in World War II, each veteran was presented with a U.S. Flag that was flown over the Capital Building along with letters of appreciation from our local Congressman and our Senator. We then visited the Lincoln Memorial, the Vietnam Wall, and the Korean War Memorial, all located on the National Mall.

We had lunch at the Franklin Delano Roosevelt Memorial. FDR was the Commander-In-Chief for these veterans. After lunch we visited the Navy and Air Force Memorials, the Women in Military Service for America Memorial, then headed to Arlington National Cemetery to witness the Changing of the Guard at the Tomb

of the Unknowns. The last stop was at the Marine Corp Memorial, often referred to as the Iwo Jima Memorial. On Saturday evening we were hosted by the Elks Club in Sterling, VA for a great dinner, then headed back to the hotel. On Sunday we flew back to Portland where a large crowd had gathered to welcome these aged veterans' home. It was a fast paced and emotional three and a half days. The veterans called it a trip of a lifetime and for most was the first time they had ever been thanked for serving their country.

When we started accepting applications, we focused on those from our most senior veterans, our World War II veterans. World War II (1939 – 1945) is what many historians now call the defining event of the 20^{th} century. Now, 22 Honor Flights later, we travel over a 4-day period and have mad many adjustments to our schedule. Through our April 2024 Honor Flight, our hub has transported 1,050 World War II, Korean War, Cold War, and Vietnam War veterans on their Honor Flight. I am very proud of the volunteers who serve our organization."



CCC & BSCC members left a day earlier to stay overnight near the departure point of Sandy, Oregon. Of course, Sandi got busted before we even left

Coburg! Before we left the parking lot in Troutdale, discovered that I left my wedding ring in the room. OOPS.


A day-by-day rundown of travel and activities would take all the remaining pages of this newsletter, so I will try to condense and only give you the highlights of our 21 day sojourn.

Day 1: We departed Dick Hannah Chevrolet in Sandy at 7:30 am. Fred bought a Red Mist C8 15 minutes before departure! Lunch at Columbia Park in Kennewick, hosted by McCurley Automotive. Spent that night in Spokane Valley, WA. Great lunch cooked and served by 3Rivers Corvette Club. The

had <u>NO</u> outside lighting in the parking lot. Hmmm.... Also noted: Butte really likes their loud trucks and motorcycles!







Lunch in Casper was *outstanding!!* Corvettes of Central Wyoming went above and beyond to welcome us to their city. They arranged for six food trucks/carts at the County Fairgrounds and were there to greet us and help us in any way needed. Super people and great food! On to Cheyenne and a "halfway" celebration at Little America. The ballroom was beautiful, people had a great time socializing and dining on \$35 tacos. After dinner, John Elegant gave a presentation on the upcoming C8 models.

Day 5: The day began with a food truck breakfast at the Chevrolet dealer in Cheyenne. There is no gentle way to say this... Worst. Breakfast Burrito. Ever. This is also where we learned that due to a medical issue John & Annie Elegant would be leaving us and driving straight home to Oregon.

Out of Wyoming and into Nebraska where we immediately noticed something we had not seen in the previous 5 states - State Troopers. Lots of them! Everywhere! We spent 1-1/2 days in Nebraska and I don't think we ever went more than +2 over. Well... there was one BSCC member who got dinged for 70 in a 55, but that was a trap! Lunch on Day 5 was a \$32 hot dog at the Archway Museum in Kearney. Yes, \$32! The museum is great, but the catered lunch...um. Stayed that night in Lincoln, NE (where we took a photo of Ducks in front of Memorial Stadium). GO DUCKS!









Day 6: We began our day at the Museum of American Speed. I have been here previously, but I continue to be blown away by their exhibits! They have nearly doubled the size of the museum and the quality of every display is incredible! Displays include bicycles, motorcycles, lunch boxes, peddle cars, engines (we almost lost Tom Thompson in the room devoted to flatheads), race cars of every type and customs. Drove through a *tiny* bit of Iowa on our way to St. Joseph, MO where we turned east on our way to Columbia for the night. Kevin & Shelley got a computer update on their new '24 C8 at a local Chevy dealer.

Day 7: A long day ahead. Left Columbia on our way to Bowling Green! Almost all freeways today. Dr. Bob told us about a route around St. Louis which we gladly took to avoid the AWFUL traffic. Crossed Illinois into Indiana and took the exit to Santa Claus, IN. From there south to Bowling Green. On I-165 (Natcher Parkway) we caught up to and joined 2 or 3 other caravans. This was just a little too much excitement when the line was running 80-85 then everyone had to slam on the brakes down to 25-30. Several well-deserved adult beverages were enjoyed that night.

Days 8 - 10: Most of us spent Thursday at the Corvette Museum because it was too darn hot to be outside. Over 100 degrees for the 3 days we were in BG. Some members did their own tours of Louisville Slugger, Churchill Downs, Lincoln's Birthplace, Mammoth Cave. A word of warning here: If you plan on seeing any of the National Parks

know their entry costs and procedures ahead of your visit. On one of our tours we stumbled upon "Miss Betty's Diner" in Park City, KY. If you ever come across a place like this in your travels, take a chance to enjoy these "backwood" places. The food and people were real down-home Southern hospitality. Suzi & Vic's 2001 had developed a very rough running condition and smoking badly while idling. The word went out on various caravan Facebook sites that we needed help at our hotel. In a short time we had two mechanics, one from Mississippi and one from Idaho, show up with their tools and diagnostic tools. It was determined that the PCV valve was

plugged and it would be safe to drive home. But, Terry & Tom Thompson went to a Napa store, bought a PCV and

installed it for them in the parking lot. The Corvette ran great again. Saturday night we rented a large van and a small SUV and 16 of us went to the Grand Ole Opry in Nashville. For those that watch The Voice, Wendy Moten, who was on Team Blake, was one of the performers — OUTSTANDING.

Day 11: Said goodbye to Bowling Green and headed west to Cape Girardeau. After checking in at C.G. four cars went north to the small town of Perryville, MO. There we found an exact replica of

the Viet Nam Wall. A local farmer has built an incredible memorial to all veterans on his land. Seeing the Wall is a moving experience. There was a plaque there that reminded me of our friend Stan.





Day 12: The days are starting to "blur". Many of us were feeling the affects of a virus we picked up somewhere in the previous days.

To avoid the freeway we took 45 mph farm roads from Cape Girardeau to Sikeston. Mistake #1. After lunch at Lambert's, the Home of Throwed Rolls, in Sikeston, we crossed southern Missouri on Hwy 60. Pretty country, but no rest areas. Made it to our stop in Joplin. On our way to Joplin we made a stop in Poplar Bluff at McDonald's for a pit stop which happened to be across the street from a Chevrolet dealer. You need to ask Don Wittish about that stop.

Day 13: Another windy, twisty detour route from Joplin to Wichita, KS. We were so desperate for a rest area we had to stop at a Dollar General in the middle of Nowhere, KS. Made it to Wichita and had lunch at a Spangles Burgers—lots of food for very little money! We had a reservation for a tour at the Frank Lloyd Wright Allen house. Some of us did that tour while 3 other cars went on to Dodge City. When we arrived in Dodge City later our GPS led us on a different route than the previous group to our hotel. We did not get to see any of Old Town Dodge City. Next to our hotel happened to be a Casino. Some had dinner there AND also there were some winners and losers.

Day 14: Just another day of crossing the Kansas plains.... Cows, crops and boring. Arrived at our hotel in Pueblo West in time to go to a nearby car wash. Then the skies opened up with thunder, lightning and downpours. A member of the local Corvette club came to take us downtown Pueblo for dinner at his favorite Irish pub. GRIS took a rock in the windshield, we met some of the local downtown *characters* and ate over-cooked fish & chips. I know.... Who orders fish in Colorado??

Day 15: This morning Len & Nikki (friends from Redmond) decided that Len was just too sick to continue. They left the group and headed home.

Our first planned stop was at Royal Gorge to see the canyon and bridge. Another lesson in knowing the entry requirements before you arrive. This was a rip-off. Number 1, it was raining too hard to be outside so we thought we would see the bridge from the Visitors Center. They charge \$37 just to go in the Visitor Center!! GRRRR..... We didn't see the bridge.

We had no plans for lunch today but we saw several signs advertising the Sunflour Café (not a misspelling) in Monte Vista, CO. After a very good lunch, this is when it all went bad. Suzi & Vic were the last car and got caught at the one and only light in Monte Vista. They got going again and eventually caught up somewhere between Monta Vista

Found a great little café in Ridgway - True Grit Café, named for the John Wayne movie that was partially shot in the area. Another gem find in a small town. Made our way to Green River, UT.
