



### **Coronavirus Covid-19 Terms and Conditions Home/Kindergarten Agreement Addendum**

This is a copy of the Coronavirus Terms and Conditions which are to be read in conjunction with the Contract and Terms and Conditions documents. These will be in place from 3rd September 2020.

These terms and conditions are in addition to the main terms and conditions and have been added in light of the coronavirus Covid-19 pandemic of 2020. All existing terms and conditions remain in place unless specifically noted below.

Your child will not be readmitted to the kindergarten if you do not sign and agree to these terms and conditions.

#### **Amendment to Terms and Conditions:**

*These amendments supersede those in the main Terms and Conditions document attached to the registration form.*

Children with symptoms on the current NHS or PHE list of coronavirus Covid-19 symptoms will not attend the kindergarten under any circumstances. This includes, but is not limited to, cold symptoms, or the need for Calpol (or similar) to control a temperature. You must inform the kindergarten manager if your child is absent due to Covid-19 symptoms.

Adults with Covid-19 symptoms will not enter the kindergarten site at any time.

We encourage all households to get tested if they have symptoms of the coronavirus Covid-19. We encourage test results to be shared with the kindergarten staff.

If any child or member of staff receive an official NHS Covid-19 POSITIVE test then that child and family should isolate for 14 days.

Due to the shared responsibility for social distancing and good hygiene practices between the kindergarten and families, closure due to a POSITIVE official NHS Covid-19 test during this 14 day period will be charged at the usual rates. This enables Little Delwood Kindergarten to continue to be financially viable during this pandemic. This is necessary as no nursery insurer will cover any nursery for business interruption due to Covid-19 related closure.

Little Delwood Kindergarten will not reduce fees if your child is absent from the Kindergarten for any reason, including illness or holidays. In addition, the kindergarten will not reduce fees for any day the kindergarten is closed due to any events outside of the kindergarten's control. In order to terminate the parent agreement or a child's place at the kindergarten you must give a minimum of one month's advance written notice. This notice period will be invoiced in full. At the end of the parent agreement, all outstanding fees will be due.

Little Delwood Kindergarten will inform via email, without any notice if the case warrants, of any closures due to isolation periods required for members of staff and reopening dates. All isolation periods for Covid-19 can be found on

the NHS website.

Little Delwood Kindergarten will confirm via email any closures due to isolation periods and reopening dates. All isolation periods for Covid-19 can be found on the NHS website.

**Additional Terms and Conditions:**

These are in addition to the Terms and Conditions in the main document and including the amendments above.

All families and staff members will follow all guidelines released by the Government regarding Covid-19. In particular all families, family members and staff members will follow the social distancing guidelines.

Wherever possible, no children attending Little Delwood will also be cared for in another childcare setting. If this is required it will need to be discussed on a case by case basis. By sending a child to our kindergarten you are confirming that your child has only been cared for by members of their household and us. Children of separated parents have two households and this is the only time this is agreeable.

New procedures for attending the kindergarten are in place and must be followed.

Little Delwood Kindergarten reserve the right to refuse admittance to any child from any family who are not following the Government guidelines. This refusal to admit a child may happen in person at the gate, and the period of non-admittance will be confirmed in writing with 24 hours of a verbal refusal. Refusal to admit a child to a chargeable session does not mean that session will not be charged for.
