## **Treasurer Report- Cindy**

- 1. All dues were collected for 2022.

- 3. Discussion to put reserves into Savings account to earn interest. Question if this would affect non-profit status. Further discussion needed in February.
- 4. Drain Fund discussed.

- e. Request Christine's neighbor to assist with landscaping.
- f. Homeowner Concern about speed limits on Salem- Melissa to see if homeowner is interested in assisting with signs/sheriff liaison.
- g. To improve participation review moving location of meeting to Library and livestreaming it. Lydia Bennett to assist with Facebook and social media presence.

#### 2. Directory and By-Laws- Christine

- a. Start work on Directory in April and print in May of 2023.
- b. Survey from 2022 did not receive amount for quorum to make a clear decision on improvements wanted by homeowners.
- c. By-laws- attorney needs to be contacted to review and write any updates. By-laws were sent to Peter.
- d. To improve participation review moving location of meeting to Library and livestreaming it.
