

Fifty Documented Indigenous Lineages from Ots-Toch, Catoneras, and Abenaki Devoe Families to Marion Bowman

This document presents fifty academically supportable genealogical lineages of Indigenous descent leading to Marion Bowman, daughter of Jesse Bowman and Marion Dunham. These lines trace primarily to two 17th-century women: **Ots-Toch**, a Mohawk wife of Cornelis Van Slyck, directly documented in Dutch and Mohawk records; and **Catoneras**, a Munsee–Canarsee woman identified in Dutch land petitions.

Each lineage is substantiated through Dutch Reformed church registers, wills, and land deeds, with reinforcement from peer-reviewed genealogies, mission records, and publications of the New York Genealogical and Biographical Society. This remains a living document, updated as new archival details are uncovered.

- **Confirmed lines (28):** Rock-solid, supported by DR records, deeds, or multiple genealogical authorities.
- **Documented/Secondary lines (15):** Well-documented families with known Indigenous connections but without a single definitive record for that exact path.
- **Provisional lines (7):** Plausible but unproven, relying on debated or circumstantial evidence.

By cultural origin, the fifty lines distribute as follows:

- **Iroquoian (Mohawk) — 21 lines:** Core Ots-Toch → Van Slyck → Van Antwerp/Wemp/Van Olinda pathways, plus collateral Groot, Van Den Bergh, Van Ness, and Fonda/Van Buren unions.
- **Algonquian (Munsee, Mahican, Abenaki, Wappinger) — 17 lines:** Catoneras → Storm, Van Tassel, Conklin, and DeVoe; Schaghticoke Mahican ties; DeVoe connections to Odanak (Obomsawin, Nolin, Panadis); and one provisional Vermont Bowman–Abenaki line.
- **Combined (both traditions) — 12 lines:** Intersections of Mohawk and Algonquian descent, especially the union of Winant Van Antwerp (Ots-Toch line) and Hester Ann DeVoe (Catoneras/DeVoe line), which concentrated multiple Indigenous ancestries.

Together, these lines reveal an unusual pattern: rather than one or two Indigenous connections, as is typical in Dutch-descended families of New Netherland, our family shows a near-even balance of Mohawk and Munsee/Mahican/Abenaki ancestry. These convergences, centered on Schaghticoke and surrounding Hudson–Mohawk communities, underscore the depth and persistence of Indigenous kinship within our lineage.

Hester Ann Devoe → Bowman line. **[DOCUMENTED/SECONDARY — Doxie DR records at Schaghticoke confirm presence; Rachel Conklin's Catoneras tie remains to be firmly proven. Secondary.]**

Line 46 Schaghticoke Conklin family → descendants of Storm/Van Tassel → Conklin branch intermarried with DeVoe family → William DeVoe (b. ca. 1760s) m. Marytje Buckhout → Hester Ann Devoe m. Winant Van Antwerp → Bowman line. **[CONFIRMED — Conklin–DeVoe–Buckhout union is DR documented. Indigenous ancestry flows through Storm/Van Tassel (Catoneras).]**

Line 47 Fonda family at Schaghticoke → Douwe Isaacse Fonda m. Aaltje Van Buren (descendant of Ots-Toch through Van Ness/Van Buren line) → Hendrikje (Hendrika) Fonda m. Lewis Simonse Van Antwerp → Douwe Van Antwerp m. Maria Van Den Bergh → Winant Van Antwerp m. Hester Ann Devoe → Bowman line. **[CONFIRMED — Fonda DR records in Schaghticoke confirm presence. Ots-Toch → Van Buren → Fonda link documented by Pearson.]**

Line 48 Van Olinda/Wemp family at Schaghticoke → direct descent from Ots-Toch via Hilletje Van Slyck m. Pieter Danielse Van Olinda → descendants intermarried with Van Antwerp line → Bowman line. **[CONFIRMED — Multiple DR-confirmed unions tie Van Olinda back to Ots-Toch. Secure line.]**

Line 49 Van Ness family at Schaghticoke/Albany → Cornelis Van Ness m. Aaltje Van Buren (descendant of Ots-Toch) → their daughter Hendrikje Van Ness m. Cornelis Van Buren → descendant Aaltje Van Buren m. Douwe Isaacse Fonda → Hendrikje Fonda m. Lewis Van Antwerp → Bowman line. **[CONFIRMED — Van Ness and Van Buren DRs in Albany/Schaghticoke confirm. Indigenous link via Ots-Toch collateral descent is strong.]**

Line 50 (Provisional — Vermont/Bowman) Bowman family in Vermont (Greenfield Center migration line) → possible marriage with a Vermont family of Abenaki descent (provisional tie: Conklin/DeVoe kin noted at Odanak and Schaghticoke had Vermont offshoots) → descendants → Jesse Bowman → Marion Bowman. **[PROVISIONAL — No direct DR or land record yet confirming Indigenous ancestry on Bowman's Vermont side. This line is marked provisional pending new evidence.]**
