### Ahh February...


*What is the definition of February? Those three months between January and March!*

## Junior Leadership Medina County

On February 2nd and 4th, we presented (virtually) to both of this year's classes of Junior Leadership Medina County. JLMC director, Carrie Park, facilitated each event. Assistant Superintendent Millikin and Superintendent Stollar educated 74 high school students on the structure, operations, and services that are provided to our youth to help them get on the right path. The students asked some solid questions on our mental health services, meal service, and other topics. This photo shows Ms. Millikin presenting a video tour of our building to the JLMC class.



Millikin and Stollar also visited each class in person at 111 Bistro as the kids were enjoying lunch there. This served to provide additional opportunity to get to know the kids better and answer even more questions.

Ms. Park reported to us after the two leadership days that many of the students commented that learning about our facility had been their favorite JLMC experience to date! Here are just a few of their remarks:

- *"I had assumed all juvenile detention centers ran like the ones on TV. Much to my surprise, the MCJDC is very focused on rehabilitation to promote a successful re-entry into society."*

- *"It makes me feel that those kids will hopefully come out of the center with a better perspective on life."*

- *"The different programs like art therapy, music therapy and journaling proved how much they care for each of their residents. This made me very proud of our JDC!"*

- *"Learning about (JDC) changed my perspective about how I thought of juvenile delinquents. Instead of just seeing the detention center as a way to get juvenile delinquents away from society, I can see it now as more of a way to change their behavior and try to make them better people so that they can return to society and not cause problems."*

On February 9th, Superintendent Stollar also presented (virtually) to the signature class of Leadership Medina County. Medina City Schools' Assistant Superintendent, Dr. Kristine Quallich, facilitated this event. We received positive feedback from that class as well - here are a couple of examples.

- *"Hearing about the detention center – had no idea about this in Medina County. It's wonderful to shine a light on these things in Medina."*

- *"Unique challenges the Detention Center faces...and how they manage to run a great program."*

If it seems that we are bragging about how we help our kids here, it's probably because we are!! :-)



Another amazing collaborative project that we are honored to be a part of! All of you, out there in our community, donated fleece fabric which was then organized by *Access the Arts*, cut by

members of *Highland's Highschool VOFT - Volunteer Opportunities for Teens*, and then tied by *our residents* to create Fleece Tie Blankets. We donated 15 blankets (20 more are completed and on the way) last week to Medina Hospital in hopes of bringing comfort to patients who are alone and suffering. It is difficult to come together in times of social distancing and isolation, but we can offer our support and compassion to those who are sick and need it most through showing them we care. 
