- Artists will be introduced via microphone, and their name, social media handles, and website will be displayed on the LED screen.
- A timer clock will be used to monitor the performance duration.
- Artists must provide a **USB drive** containing their music.
- If performing with a **live band**, the band must be fully prepared and ready to perform at the scheduled time.
- **There will be no stoppages or delays**, as this will result in a reduction of the artist's performance time.
- Artists will be introduced via microphone, and their name, social media handles, and website will be displayed on the LED screen.
- A timer clock will be used to monitor the performance duration.
- The total music duration must not exceed **12 minutes** to maintain the **15-minute** performance timeframe.
- It is recommended that artists perform a **potpourri** to showcase their style and music effectively.
- Artist must arrive at the venue at least **60 minutes** before their scheduled performance time.



- Artist must provide their own instruments/equipment unless otherwise agreed upon.
 - Artist must comply with all venue and event regulations, including sound and performance guidelines.
 - Artist grants Organizer permission to use their name, likeness, and performance recordings for promotional purposes related to the event.
