# **GUIDE TO HEALTH CARE SERVICES IN THE RICHMOND HIGHWAY COMMUNITY FOR LOW-INCOME, UNINSURED, OR UNDERINSURED RESIDENTS**

Where can low-income, uninsured, or underinsured residents turn for health care? This guide can help residents, their families, and service providers find the best starting place. The guide covers the Richmond Highway Community in Fairfax County. See page *iii* for a map of the Route 1 Community.

For the most recent information, call the clinics.

Charts for the clinics are listed alphabetically in this guide. Each chart gives the same type of information on each clinic. The questions below direct you to a clinic that can meet your needs.

**Answer the three questions below to see which clinic you should start with.**

**1. Do I have adequate insurance to cover my needs?**

- Yes.** Call Neighborhood Health or a private practice.
- No.** Call **Simplicity Health**. See below.
- I don't know.** To make an appointment to check if you are eligible, call **Neighborhood Health** or the **Fairfax County Health Department**.

**2. Is my income less than twice the federal poverty level? That level is about \$25,000 for one person or \$43,000 for a family of three.**

- Yes.** You can go to most clinics in this guide.
- No.** Call **Simplicity Health**. See below.
- I don't know.** To make an appointment to check if you are eligible, call **Neighborhood Health** or the **Fairfax County Health Department**.

**3. What type of care do I need?**

- Pre-natal**  
Call **Fairfax County Health Department** for qualification and referral to Inova Cares Clinics for Women.
- Family (pediatric, adolescent, or adult)**  
Call **Neighborhood Health** or **Fairfax County Health Department**.
- Adult**  
Call **Neighborhood Health, Fairfax County Health Department, or Simplicity Health**.
- Mental Health/Substance Abuse**  
Call **Fairfax-Falls Church Community Services Board**.
- Dental**  
Call **Neighborhood Health** or **United Community** for a referral to **Northern Virginia Dental Clinic**. The **Fairfax County Health Department** offers dental services for people under age 20 on Medicaid or income-eligible.



The **Fairfax County Richmond Highway Community** runs from the City of Alexandria to the Prince William County border through the Fairfax magisterial districts of Mount Vernon and Lee.

The corridor transverses the neighborhoods of Huntington, Mount Eagle, Belle Haven, Groveton, Bucknell, Hybla Valley, Woodley, Woodlawn, Mount Vernon, Fort Belvoir, Mason Neck, and Lorton.



## INTRODUCTION

South County saw two big changes to health care for low-income uninsured and underinsured residents in 2019.

First, on January 1, about 400,000 adults in Virginia, about 30,000 of them in Fairfax County, became eligible for Medicaid Expansion, which was passed by the Virginia General Assembly in 2018. By July, 300,000 of those eligible had signed up for the program. Medicaid expansion provides coverage for adults with incomes up to 138 percent of the federal poverty level, which is \$16,750 a year for a disabled person or able-bodied adult and \$28,700 for a family of three. Providers in this guide, especially Neighborhood Health and Fairfax County, can help residents sign up for this benefit.

Second, as of July 1, Fairfax County Health care services for uninsured and underinsured residents were reorganized. In the Lee and Mt. Vernon Districts, Neighborhood Health, a non-profit federally qualified health center, has taken over many of the duties and facilities of the Fairfax County Community Health Care Network, which had provided primary care services to approximately 16,000 low-income county residents. The Merrifield and South County Center clinics became part of the Neighborhood Health system, which now operates 12 clinics throughout the county, including three in South County.

Fairfax County provides financial support to Neighborhood Health to build capacity, increase access to integrated primary care, and expand the safety net for delivery of family health care services.

Neighborhood Health offers:

- Affordable, primary care services, including medical, dental, and behavioral health services. These services are available for families, including children.
- Referrals to partnerships with local hospitals and other community providers for specialty care.
- Free translation services and staff who speak languages other than English.

This updated guide reflects the changes in Fairfax County and Neighborhood Health services. Other providers in this guide reviewed and updated their listings.

We received many compliments on the usefulness of the first (2018) edition of the guide from county social service providers, nonprofits, and faith communities that run food pantries and other services.

This guide is available free at Route 1 Community health clinics, social service nonprofits, the Gerry Hyland South County Center, the Gartlan Center and many of the area churches belonging to Ventures in Community. An electronic version is distributed with the South County Task Force Newsletter. It is also posted on the websites of several nonprofits including United Community and Ventures in Community.

<b>South County Location</b>	South County Center, 8350 Richmond Highway, Suite 233 Four other clinics throughout Fairfax County.
<b>Phone</b>	703-704-5203
<b>Website</b>	<a href="http://www.fairfaxcounty.gov/health/clinics">www.fairfaxcounty.gov/health/clinics</a>
<b>Who served</b>	We offer public health services such as vaccinations, TB testing, refugee health screening, and international travel health services.  We serve low-income children and adults, including pre-natal care.
<b>Service area</b>	Fairfax County, the City of Fairfax, and the City of Falls Church.

## ELIGIBILITY

<b>Financial eligibility</b>	Fees and eligibility vary by program. Make an appointment with a family assistance worker to see if you qualify for particular programs.
<b>Insurance accepted</b>	Some. See family assistance worker when signing up.
<b>Fees</b>	Sliding scale for some services depending on your income.
<b>Residential eligibility</b>	You must be a resident of Fairfax County or the cities of Fairfax or Falls Church (except for sexually transmitted infections services).

## SERVICES

<b>Adult</b>	Yes.
<b>Pediatric</b>	The Infant Development Program provides services for infants from birth to age 2 who may have developmental issues. Services include evaluations, specialized teaching, referrals, and possible home visits by a public health nurse.  The Women, Infants and Children (WIC) program is a federally funded supplemental food program for pregnant, postpartum, or nursing women, and infants, or children under age 5. Clients must be at nutritional risk and income eligible.
<b>Pre-natal and Post-Partum care</b>	Pregnancy testing and comprehensive pre-natal care offered in partnership with Inova Cares Clinic for Women. We offer the federal WIC nutrition program (see above).  Home visiting services include pre-natal support; postpartum follow up; assessment and support for depression or intimate-partner violence; support for parenting skills and parent-child bonding; and checks for infant developmental delays.
<b>Preventive care</b>	The FCHD provides routine, non-routine, and travel immunizations to adults and children. Most childhood vaccines are free; payment plans can be set up for any charges.

# FAIRFAX COUNTY HEALTH DEPARTMENT (continued)

## SERVICES continued

<b>Dental</b>	Dental services are offered to those under age 20 who have Medicaid or are income-eligible. Some dental services: (exams, cleanings, restorative services, and extractions) are offered to pre-natal women served by Inova Cares.
<b>Eye care</b>	In partnership with Lions Eye Care clinic and community providers, clients get a free eye exam and basic glasses.
<b>Behavioral care</b>	Referrals to Community Services Board and Federally Qualified Health Centers.
<b>Lab work</b>	Limited.
<b>Medications</b>	Yes, for certain communicable diseases.
<b>Public Health Services</b>	<b>Fairfax County’s Division of Epidemiology &amp; Population Health</b> provides surveillance of communicable and noncommunicable diseases; case and outbreak investigations; prevention and population health assessments. A <b>tuberculosis control program</b> provides evaluations, chest x-rays (Annandale and Fairfax locations), medication, treatment, and follow-up. A <b>sexually transmitted infections program</b> provides testing, medications, counseling, oversight of treatment, and education. Services are confidential and payment is on a sliding scale based on income. Free to those under age 19. Clinics on Mondays and Fridays by appointment.
<b>Other</b>	Speech and hearing services for children and adults; Adult-Day Health Care center for older adults; public health nurses and school health aides that serve schools in the South County; child car safety seats.
<b>Specialists</b>	Infectious disease specialists for tuberculosis and sexually transmitted infections. Referrals to other specialists.

<b>Who served</b>	People who have mental illness, substance-use disorders, and/or developmental disabilities. Early intervention services for infants and toddlers who have developmental delays. On-site primary care is available to CSB clients at the Gartlan Center through a partnership with Neighborhood Health.
<b>Service area</b>	Fairfax County, the City of Fairfax, and the City of Falls Church.

### ELIGIBILITY

<b>Financial eligibility</b>	No specific income requirements—it depends on the service. Fees are based on the “Ability to Pay Scale” (see website). Fee depends on income and number of dependents as shown on your most recent tax return.
<b>Insurance accepted</b>	Public and some private insurance accepted. CSB can file claims and accept reimbursement with most health insurance plans for those eligible for services.
<b>Fees</b>	Yes. Fees help offset the cost of providing services.
<b>Residential eligibility</b>	Residents of Fairfax County and the cities of Fairfax and Falls Church.

### SERVICES

<b>Adult</b>	All residents can access CSB emergency services; entry and referral services; and wellness, health promotion, and prevention services. Other nonemergency services are primarily for people whose conditions seriously impact their daily functioning. Priority is given to those with substance-use disorders, pregnant women and girls, intravenous drug users, and people asking for treatment for abuse of heroin and other opioid drugs. <b>Contact CSB</b> if you have concerns about mental health, substance use, or intellectual or developmental disability. It will offer you appropriate treatment and resources or refer you to other service providers in the community.
<b>Pediatric</b>	Contact the Infant and Toddler Connection services (see website) if you have children up to age 3 with developmental delays. You must meet certain eligibility requirements for treatment. Adolescent and youth services are provided at the South County Center.

<b>Pre-natal care</b>	No.
<b>Preventive care</b>	CSB Wellness, Health Promotion & Prevention Services engage the community in activities to strengthen emotional health. They also help community members handle complications related to substance use and mental illness.
<b>Dental</b>	Dental care is through Neighborhood Health at their clinic.
<b>Eye care</b>	No.
<b>Behavioral care</b>	Yes. Mental illness, substance abuse, and developmental disabilities.
<b>Lab work</b>	Labs are provided on site by LabCorps for CSB clients on scheduled days.
<b>Medications at lower prices</b>	Yes. Genoa Pharmacy is located at Gartlan Center. The Patient Assistance Program provides some medications.
<b>Specialists</b>	Our staff and contract service providers include psychiatrists, psychologists, nurses, counselors, therapists, case managers, and peer specialists.

<b>Emergency services</b>	For emergency mental health services 24/7, call 703-573-5679. Or go to Merrifield Center (address below), lower level, rear entrance, park on level P-2. Call 911 immediately if you are in a life-threatening situation and ask for a Crisis Intervention Trained officer.

<b>Who served</b>	Low-income children and adults.
<b>Service area</b>	The Route 1 Community as well as Alexandria, Arlington, and much of Fairfax County.

## ELIGIBILITY

<b>Financial eligibility</b>	Clients at or below 200 percent of the poverty level can receive services for a fee on a sliding scale.
<b>Insurance accepted</b>	<p>Medicaid; FAMIS, Virginia's health insurance program for children; Medicare; and private insurance from most insurance plans. Half of patients don't have any health insurance. Fees can be lowered on a sliding scale for low-income people who don't have insurance or who have insurance with high co-pays and deductibles.</p> <p>Low-income Medicare patients without drug coverage can get cheaper drugs.</p>
<b>Insurance enrollment assistance?</b>	Yes. Call 703-535-5568. We help sign people up for the Affordable Care Act; we help sign up children and adults for Medicaid.
<b>Fees</b>	For those at or below 200 percent of the poverty level, sliding scale fee payments range from \$15 to \$58 for a medical visit. A lab fee is about \$19 to \$25. Higher fees apply for those with incomes over 200 percent of the poverty level.
<b>Residential eligibility</b>	None.

## SERVICES

<b>Adult</b>	Yes. We are a primary care medical home. We offer services similar to those of any private family practice, including women's health and family planning.
<b>Pediatric</b>	Yes, at two locations: 6677 Richmond Highway and 2616 Sherwood Hall Lane.
<b>Pre-natal care</b>	Pregnant women are referred to the Fairfax County Health Department.
<b>Preventive care</b>	Yes. Includes preventive care, such as immunizations and cancer screenings.
<b>Dental</b>	Yes, basic care (exams, x-rays, cleaning, fillings, extractions); no root canals or dentures. Referrals to Northern Virginia Dental Clinic.
<b>Eye care</b>	Basic eye screening.
<b>Behavioral care</b>	Yes. Behavioral health services are integrated with the medical care. We screen people for depression. If you screen positive, you can be seen by one of the counselors on-site. We also work with the Community Services Board at mental health care sites like the Gartlan Center.
<b>Lab work</b>	Yes

<b>Specialists</b>	Referrals.

<b>Fees</b>	Clients are responsible for the cost of their treatment. Basic service fee is \$50 per visit. Additional fees for dentures, partial dentures, denture relines and repairs, night guards, crowns, biopsies, and prosthetics.

<b>Who served</b>	Primary care services for adults who don't have health insurance, or have insurance with a very high deductible, and who don't qualify for Medicaid. No income requirements.
<b>Service area</b>	Simplicity Health has three clinics: one in Alexandria on King Street close to the Alexandria Health Department, one in Annandale, and one in Sterling.

## ELIGIBILITY

<b>Financial eligibility</b>	No financial qualification process, no financial clearance.
<b>Insurance accepted</b>	Yes.
<b>Fees</b>	Pay a nominal subscription fee of \$80 a month. This covers access to a primary care provider and any labs needed as part of that service. Follow-up visits with that provider within four weeks are included in the \$80. You won't have copays or additional costs during those four weeks. The \$80 fee can be renewed for every four-week period.
<b>Residential eligibility</b>	Northern Virginia residents.

➡ Call Fairfax-Falls Church Community Services Board.

#### DENTAL

➡ Call Neighborhood Health for routine care. For more severe problems, ask Neighborhood Health or United Community for a referral to the Northern Virginia Dental Clinic. The Fairfax County Health Department offers dental services for people aged 3–20 who are on Medicaid or income-eligible.
