ANNUAL MEMBERSHIP FEES: INDIVIDUAL - \$60 FAMILY - \$90 JUNIOR -\$25 In Lieu of Activity -\$120 (max)

*A Family is defined as Couples and Dependents under 18 living together. A Junior is under the age of 18 and is not covered by a Family Membership. **There will be no proration of Annual Membership Fees.***

ACTIVITY REQUIREMENTS:

Every Member over the age of 18 with an Individual Membership, and each Family Membership, must complete an Annual Activity Requirement of 12 hours of volunteer work in order to maintain membership. Families may choose to divide the Activity Requirement amongst themselves. **In lieu of the Activity Requirement**, all Memberships may choose to pay an additional fee, due upon joining or renewing a membership, based on \$10 per hour not to exceed \$120 annually. At the end of the year, Memberships will be assessed a fee for any unworked hours based on the rate of \$10 per hour. For example; Six (6) unworked hours x \$10/hour = \$60. **The fee for any unworked hours will be due at the time of renewal for Membership the following year.**
