I want to participate in and /or observe **Northwest Territorial 2022**, and I understand that I will not be allowed to do so unless I agree to give up my right to sue for personal injury, wrongful death, and property damage in exchange. I hereby bargain for and agree to that exchange.

I make this contract in consideration of being permitted to participate in and/or observe Northwest Territorial 2022 and related activities (hereinafter NW Territorial ), presented by Oregon Trail Rough Riders.

I am fully aware of the dangers inherent in the sport of Cowboy Action Shooting, which involves the use of loaded guns and live ammunition.

I hereby assume full responsibility for the risk of bodily injury, death or property damage that may occur while I participate in and/or observe Middle of the Road , whether caused by negligence or otherwise.

I hereby release and forever discharge Idaho State Championship, Oregon Trail Rough Riders, Black's Creek Shooting Range, Idaho Department of Fish and Game, State of Idaho, and the Single Action Shooting Society (SASS), all sponsors, all promoters, advertisers and vendors and their officers, directors, employees, and agents from all liability for any and all loss or damage on account of injury to my person or property, even injury resulting in my death, whether caused by negligence or otherwise while I am participating in and/or observing NW Territorial.

I further release the above-mentioned entities and person from any claim whatsoever on account of first aid, treatment or service rendered me during my participation in and/or observation of NW Territorial.

This release shall also be binding upon my spouse, my marital community, my estate, my legal representatives, heirs, assigns, and all other persons entitled by law to sue because of injury to me or my death.

If this contract is made on behalf of a minor, I have legal authority to do so.
