Eric's Accounting Services Eric's accounting charges of \$260 for July and \$340 for

August were reviewed and felt appropriate for the hours involved (Approximately 40 hours in July and 60 hours in August). Eric will type up a formal PO to be approved by the board and discussed at the annual owners meeting. Base charge per month will be \$100. Extra charges will be allowed for placing or removing liens (\$100), Certification process for sales (\$100 charged to buyers), and Mailing Services (\$50) plus

office expenses.

A/R Review We are down to two lots with balances (39-\$600 & 67-

\$900). Both are on Payment Plans and should be paid

off by the end of the month.

P&L, and Cash Flow Review We have \$11,181 in the bank with all the legal bills paid

for. We are forecasting \$7,500 to be in the bank at the

end of the year.

Budget Review We will be keeping dues at \$400 in 2024. Estimated

expenses including \$10,000 for the storm water collection vault will still leave us with a surplus of \$7,000 for the year. This should leave us with \$14,500

at the end of 2024.

Billing Process/Dates We will bill \$400 on 1/1/24 with a due date of 3/31/24

On 4/30/24 and every month end after, outstanding

balances will be charged a \$50 late fee.

Liens will be put on any lot with a past due balance of \$1,000 or more. \$250 Legal Fee for Liens added and

\$200 for Liens removed.

Annual Meeting

We set up a date of Wednesday October 25, 2023 at 6:30 PM sign in and 7:00 PM start time.

Agenda items include: Transition Update, P&L and budget review, Dues amount and payment schedule, ACC process, and Q&A

Ryan to arrange Carlton Farms and bring coffee and snacks.

Eric to type up a Meeting Letter for review and mail them once reviewed.

Ryan will contact an hourly lawn service and arrange at least one more lawn mowing and two leaf blowing services. Eric can handle a day time site visit if needed.
