INSTRUCTIONS

In addition to the application, you will need to submit an original of the following attachments:

- 1. Full details of the purpose and/or reason for improvement.
- 2. Site plan with scale drawings of exact dimensions of improvement showing location on the property. Note distance from property lines. Show relationship of improvement to neighboring homes and/or open spaces.
- 3. Drawings and/or illustrations showing the design of proposed improvement state the architectural style of an existing home.
- 4. Materials/Color:
 - a. List the type of wood or other materials to be used.
 - b. Color: note whether the color is the same as existing siding or trim on house or attach a color chip for other colors/stains.
- 5. Grading plan if changes in grade or other conditions adversely affecting drainage are anticipated (approval will be denied if adjoining properties are adversely affected by changes in drainage).
- 6. Landscape plan if the application is for landscaping or relevant to the project.
- 7. Signed written agreement of affected lot owner if improvement falls on the property line.

ACKNOWLEDGEMENT OF APPLICANT

- 1. I understand that construction of certain major projects requires that I obtain a City or County building permit. Approval of a project by the ACC does not affect or alter that requirement.
- 2. I understand that no construction activity shall take place before the approval of the ACC. The ACC will take a minimum of 1 day and a maximum of 30 days to approve the project. If alterations are made before approval, I may be required to return the property to its former condition at my own expense if this application is not approved wholly or in part, and I may be required to pay all legal expenses incurred if legal action becomes necessary.
- 3. I understand that members of the Architectural Control Committee are permitted to enter my property to make a reasonable inspection of proposed construction locations.
- 4. It is understood that I am aware of the Covenants, Conditions, and restrictions and Architectural Controls regarding the review process.
- 5. I understand that any approval is contingent upon construction or alterations being completed in a workman-like manner as per the plans submitted.
- 6. I understand that if I disagree with the ACC ruling, an appeals procedure is provided directly through the Board of Directors.
