



Limited Warranty

Warranty Includes

The warranty covers peeling and blistering throughout the entire reglazed surface caused by defects in the product or workmanship. If in any case the surface peels, cracks, is scorching, or is fading, it must be notified immediately, or the warranty will be voided. Clients must also provide an invoice for the product in interrogation. We will examine the problematic area and determine whether the damage was caused by an inadequacy in the product or expertise. If the warranty holder notifies Premier Bath Reglazing within the warranty period of any foregoing defects in the material and the investor shows the substance that was used and maintained in obedience with the Premier Bath Reglazing "How to clean & maintain reglazed surface" sheet and standard industry practice, Premier Bath Reglazing will repair the failing area only. PLEASE REFER TO OUR WARRANTY ADDENDUM ON HOW WE DETERMINE A WARRANTY CLAIM FOR PEELING.

Warranty Excludes

Keep out (but not bound to): chipping, gash, discoloration, or blade marks due to misapplication or mishandling of the surface, grinding damages, discoloration due to peroxide, pigment, or acids, and/or problems created by plumbing leakage or any rust damage. Wall structures that are not kept in a watertight condition. Sharpened or ponderous objects and bath mats with suction cups may create damage to the surface. The usage of grating products such as Ajax, Comet, or bleach may stain or damage the surface area due to the heavy cleaning and/or heavy use of it. Plumbing may end up leaking onto the refinished area and cause damage. Any damage that was caused by heavy use, heavy cleaning, and/or leaking plumbing is distinctly not under this warranty. Warranty can only be claimed by the person whose name appears on the invoice (no exceptions). The warranty is non-transferable. No warranty is offered for properties on sale or in the market. The area in such needs to be no bigger than 10 inches by 10 inches to validate the warranty. It is the responsibility of the warranty holder to report any possible warranty in a timely manner. Water that goes under the paint may cause bigger peeling, and this will be considered negligence.

Also Warranty Excludes

This guarantee is exclusive of any implied warranty of merchantability, health for a particular purpose, or other qualities of the warranty, whether implied or expressed, disregarding the warranty of title and opposed to patent violation. Seller's workers' oral declaration doesn't constitute warranties, should not be relied upon by Client, and is not part of this agreement. There aren't any warranties which expand beyond the description of the face hereof. Healing of the defects, in the manner and for the period of time given above, should constitute the client's sole remedy with respect to the product. Any scratching, deterioration of the glossy finish, or staining over time due to usage, cleaning practices, or water conditions will be considered normal wear and tear. Premier Bath does not warranty kitchen & bathroom sink refinishing, tile shower floor refinishing, grout lines, gap between any kind of wall and porcelain tub, terrazzo, or rust repairs.
