Bitch Qualifications

- A) BITCH must be registered by the American Kennel Club or any other Foreign Club, and must be over 24 months.
- B) BITCH owner must provide STUD DOG Owner with BITCH'S 3 generation pedigree.
- C) BITCH Owner warrants that this BITCH has not been exposed to any other STUD DOG from the start of her heat cycle.
- D) BITCH Owner will provide at their expense current brucellosis results and a vaginal culture report performed within 14 days of the expected breeding.

Stud Fee and Expenses

1. A STUD Fee of \$_____ is to be payable to STUD DOG Owner in full at the first mating or AI insemination by forms of CASH, PAY PAL, or APPLE PAY.
2. The BITCH Owner is responsible for any and all fees associated with breeding, including but not limited to Veterinary Services, Container Fees, Shipping Fees, Progesterone level test or AI Fees.
3. The Owner of the STUD DOG guarantees that the BITCH whelp 2 live puppies born. For some reason BITCH fails to whelp or whelps less than 2 live puppies, the BITCH Owner must notify the STUD DOG Owner within 7 DAYS of the expected Whelp Date. In these cases the STUD DOG Owner will provide one repeat STUD Service to the NAMED BITCH on this contract or an agreed upon BITCH OWNED or CO-OWNED by same owner. In the case of a substitute BITCH, ALL requirements of the original contract must still be met. In the case Bitch changes Ownership, there is NO OBLIGATION on the part of STUD DOG Owner to repeat services.
4. If , after the second mating or AI , the Original BITCH again fails to Whelp, the STUD DOG Owner will offer services of STUD DOG once more, only after the BITCH has undergone examination by a

Reproductive Veterinarian and has had a ovulation timing. Any attempt to mate or AI after the second unsuccessful mating or insemination will be at NO expense to the STUD DOG OWNER. In this case BITCH Owner will also incur the expense of Frozen Semen collection if the BITCH is to be inseminated in this manner.

5. The STUD fee shall not be refunded, in whole or in part, for any reason, except as specifically provided for within this Contract.

STUD DOG OWNER reserves the right to deny any BREEDER or BITCH for any reason. In case that the breeding has previously been approved, STUD DOG Owner also reserves the right to later refuse any BITCH that is aggressive to any person while attempting to breed naturally or artificially or whose breeder is found in bad standings with the American Kennel Club or any Foreign Kennel Clubs. In either case, full STUD Fee, MINUS \$200.00 for expenses, will be refunded. In breeding animals there is always a risk that one may be injured during the process. BITCH Owner agrees to hold the STUD DOG Owner harmless from any liability or damage. In addition, the BITCH Owner understands that the STUD DOG Owner accepts no liability for the actions of this BITCH while in the care, including but not limited to personal injury or property damage.

This constitutes the full agreement of the parties. There are no guaranties or warranties either expressed or implied beyond what is stated in this contract.

This contract shall be deemed a legal and binding agreement between STUD DOG Owner and BITCH Owner and I the jurisdiction of the State of Michigan in the County of Macomb. It is further agreed that any dispute/arbitration between STUD DOG Owner and BITCH Owner regarding said breeding occur that the legal venue shall be in the County of Macomb.

I/WE the BITCH Owner, certify that I/WE have read the forgoing contract, and understand it's contents and I/We hereby agree on the terms of the contract.
