The funding award for this project is consistent with these recommendations and includes implementing the following items:

- Two upgraded stream gages on the Cosumnes River.
- One new stream gage on Deer Creek.

A draft funding agreement is being developed and will be sent to you for review and ultimately your agency's execution. You may begin incurring costs once the agreement is fully executed. No reimbursement of Eligible Project Costs will be issued until after the funding agreement is executed. Any costs incurred are at your own risk and liability until the funding agreement is executed.
