ORDINANCE 2019-13**

**AN ORDINANCE OF LAKETOWN AMENDING THE WATER ORDINANCE OF  
LAKETOWN CODE TITLE 8 CHAPTER 1 SECTION 3A ADDING THE  
CONNECTION FEE IS FOR THE STANDARD SIZE METER (5/8") AND  
ANY COST FOR A LARGER METER IS  
THE RESPONSIBILITY OF THE PROPERTY OWNER**

**WHEREAS;** The Town has a water department, and the waterworks is constructed, owned and controlled by this town to supply the town with water, and

**WHEREAS;** The waterworks is the property of the town and under the sole and exclusive control of the Town Council, and

**WHEREAS;** Installation, repair, alteration of waterlines or to connect any water line to the town culinary water system requires a construction permit from the office of the town clerk or from the Town Council, and

**WHEREAS;** The Laketown Planning and Zoning Commission recommends this addition, and the Town Council desires to amend the Town Code water regulations and has conducted a public hearing on the proposed amendment.

**NOW THEREFORE, BE IT ORDAINED** by the Laketown Town Council that the Laketown Code water regulations ordinance 8-1-3A Service Rates and Connection Fees be amended.

**SECTION 1:** Language to be added.

8-1-3A Service Rates and Connection Fees: The rates, penalty fee for delinquency in payment, connection fee, reservoir fee, inspection fee and other charges incidental to connection and services from the town water system shall be fixed from time to time by resolution enacted by the town council. The town council may from time to time promulgate rules for levying, billing, guaranteeing and collecting charges for water services and all other rules necessary for the management and control of the water system. Rates for services furnished shall be uniform with respect to each class or classes of service established or that may hereafter be established. The connection fee is for the standard size meter (5/8") and any cost for a larger meter is the responsibility of the property owner.

**SECTION 2:** This ordinance shall take effect upon adoption.
