

Criteria for Admission

- ❖ Bible Institute of America Inc. welcomes you as an adult student.
- ❖ The applicant must be 18 years of age
- ❖ Credentials for admission will be reviewed by the Board of Directors.
 - a. A copy of your high school or GED transcript or diploma.
 - b. Completed admissions application.
 - c. Copies of Theological Seminary transcripts or diplomas for all schools attended.
 - d. Summary of life experience portfolio/resume
- ❖ We seek students who will contribute to, and benefit from, the Biblical Studies program that we offer.
- ❖ Any previous Theological Seminary experience, courses, training, or religious courses will be reviewed first in order to apply to the degree programs
- ❖ You may pre-register at any time by filling out the application. The application fee is \$10.00. Upon approval of application, it is required that the registration fee is paid before classes will begin. You will be required to sign an awards letter for any payment arraignments for tuition. (For more detailed information, please contact the Dean of Student Affairs @ 877-570-4407 x2).

Standards

Policies

STANDARD I: Structure & Governance:

All Bible and theological courses must be based on evangelical doctrine (see Evangelical Doctrine Statement). The organization and operation of the educational facility is in accord with appropriate statutes. There is on file a copy of the legal instrument creating the educational organization. The organizational structure and charter must reflect adequate personnel to accomplish the stated purpose and goals of the educational institution.

STANDARD II: Material Resources

The institution must have as a minimum an administrative office with sufficient space to accommodate staff, appropriate files, and records. The institution must provide students with an annually updated list of library and media resources. The institution must have adequate media equipment to evaluate student requirements and project. Classroom facilities are adequate to accommodate student needs.

STANDARD III: Refund Policy

Students may change or drop a program at any time during the first week of classes. When a program is dropped or withdrawn from and no substitute is taken, no refund will be awarded after the first class. No refunds are given after the first class. There are no refunds awarded for book fees. A student must notify Bible Institute of America Inc. in writing of the intention to withdraw or drop a program.

STANDARD IV: Faculty

The institution maintains written criteria for faculty appointment. Faculty/Student ratio reflects realistic workload. Written faculty contracts are maintained and annually updated. Faculty payment policies are consistent and non-discriminatory. A method exists for faculty input into administrative decisions.

STANDARD V: Curriculum

The institution must maintain an annually updated list of courses offered. The institution has a curriculum committee that oversees academic offerings. Degree requirements are in keeping with generally accepted standards. Students must receive a copy of the degree plan. Course requirements for students are consistent within departments or divisions.

STANDARD VI: Evaluation

The institution maintains an organized evaluation system for student performance, organizational effectiveness, and faculty performance.

STANDARD VII: Payments

ALL financial payments are due on the 1st business day of each month. ALL financial payments are considered late on the 5th of each month. Any payments submitted after the 5th of the month will require a \$15.00 late fee applied to the account. Any payments that have not been received by the 15th day of the month will categorize the student as discontinued. The student will not be able to return to classes until the payment has been submitted. If the student misses three classes during that time period the student will be dropped from courses. Students will be able to resume courses the following quarter. Payments made before the student was dropped will be able to be applied to the account if the student decides to return within 2 quarters. If a student doesn't return within 2 quarters, the student will have to begin the registration process.

Attendance Policies

Attendance

- ❖ All students are expected to attend every scheduled class.
- ❖ Students are expected to attend classes on time.
- ❖ Attendance is documented for each scheduled class meeting beginning with the first scheduled class. (sign in sheet will be provided)
- ❖ When you have arrived for class, please make sure that you sign the attendance sheet and document your time of arrival.
- ❖ If you are going to be late, you must communicate with your instructor as to how late and why. This also applies to leaving class early. Inform your instructor, and document your departure time. (sign in/out sheet)
- ❖ If you are over 30 minutes late, you will be counted as absent with the exception of pre-approval from your instructor.
- ❖ Students are allowed two (2) legitimate absences per quarter. There will be an evaluation process after the second absence. Upon review by the BOD student could be dropped from the quarter.
- ❖ In the event of an emergency, the student must notify the instructor as soon as possible.
- ❖ After four absences, the instructor may drop the student if the student does not make every effort to contact him/her.
- ❖ If there are extenuating circumstances, the instructor has the authority to make an exception to the attendance policy.
- ❖ An emergency can be defined as a sickness, family emergency, or family crisis.
- ❖ Situations beyond the limit of the policies or the privilege of the instructor can be appealed. You will have to be evaluated for an appeal and schedule a meeting with the President and BOD.

Note: Any official class closing will not be counted as an absence. This may include inclement weather, holidays, etc. However, to maintain your grade, the assignments must be completed per course schedule.

84-77 = C

Anything under 77 is a D or incomplete

Grade Points

In order to graduate, a student must earn a sufficient number of grade points to equal twice the number of semester credit hours attempted. A student's grade point average (GPA) is computed by dividing the number of grade points earned by the number of semester hours attempted. Accumulated average of two grade points per semester hour is necessary for graduation.

Change of Grade

It is the students' responsibility to retain all assignments, quizzes, and exams until final grades are received in the event an error in calculating or reporting a grade has been made. In the case of such an error, the student should immediately present his/her case to the instructor. If warranted, the instructor will then initiate a change of grade in the office of admissions and records. The deadline for a grade change request is six weeks after the close of a semester. The academic dean must approve all changes of grades.

Incomplete Grades

An "I" incomplete grade is given when a student, due to illness or an emergency situation beyond their control is unable to complete their final project or final exam before the end of semester. Work must be turned in within two weeks from the close of the semester; otherwise, the student will receive a failure "F" for the incomplete work. The final grade will be adjusted according to the average of the course work and the final "0" grade.

Examinations

Students receive a syllabus for each course they are enrolled. Students are responsible for noting the dates on which the instructor has scheduled quizzes, exams, mid-terms and/or finals.

Make Up Policy

All exams must be made up within 5 days of the date of the original exam (excluding weekends).

1. Illness

In the case of illness, the student must notify the administrator/dean of school of his/her illness.

2. Non-Illness

Students who miss an exam for non-illness reasons should make an appointment with their professor to make up the exam. Students not taking the exam with the prescribed time period will receive a “0.”

Applicant must:

1. Be 35 years of age or older
2. Provide a full ministry resume
3. Have 7+ years of ministerial experience
(Pastor, evangelist, chaplain, etc.)
4. Provide 3 References
-must have known applicant for > 5 years (must have contact number and address)
*years known, confirmation of details of resume
5. Complete a doctrinal statement of salvation, Trinity, Holy Spirit.: 200 words
6. Provide a recent photograph of him/herself.
7. Fee for the Honorary Degree Association is \$3500.00 (payment plans with 50% down. Must be paid in full to receive degree)
8. Each honoree will be subject to a background check.

THESIS REQUIREMENTS FOR EARNED DEGREES

*** MASTERS DEGREE**

One (1) thesis is required. Amount of words depends on the degree you're seeking.

***DOCTORATE DEGREE (D.C.C., D.C.E., D.Min., & Th.D.)**

Two (2) thesis are required. Amount of words depends on the degree you're seeking.

NOTE: Thesis' **MUST** be typed, single-spaced, 12 point font. There is approximately 250-280 words per page. Therefore, it will take approximately 4 pages to equal 1,000 words.

Guidelines for Honorary Doctorate Degree in Chaplaincy

- Each chaplain-elect will be nominated by an individual, organization, ministry, association, and/or alumni. If the chaplain-elect was not nominated, he/she must provide 7 references of various types to BIOAIAC.
- Each chaplain-elect will undergo a background check
- Chaplaincy registration must be completed and submitted before the process begins
- \$2,000.00 U.S. Currency Chaplaincy License and Certification fee must be submitted to BIOAIAC.
- Chaplaincy Exam: (1) Exams are divided into 4 stages (2) 2,000 word dissertation/thesis
- \$300.00 annual association fee must be met each year.
- Annual Gathering of the Chaplains. Location will vary and be announced prior to the date.

• Each Chaplain will receive each of the following items:

- BIOA Chaplain T-Shirt
- Sports Jacket w/ BIOA Logo, chaplain, and name
- Badge with leather holder
- License w/ cover (11x17 and 8.5x11)
- BIOA Chaplain Directory
- Appearance at each event, ceremony, conference, and all functions held by BIOA
- There will be three (3) Commencement Ceremonies each calendar school year.

Procedures and Order of Steps:

1. Complete registration and submit to the Chief Administrator of BIOA. \$150.00 Registration
2. Complete all documents and agreements and sign. Signatures needed: Chancellor, Vice Chancellor, Chief Administrator, and the Recipient
3. Submit Payment to BIOA of \$2000.00
4. Complete the 4 stage exam process
5. Completion of 2000 word dissertation
6. Interview with Board of Directors of BIOA
7. Chaplain-Elect will be eligible for graduation upon completion of the aforementioned items

Plagiarism

Any material, whether published or unpublished, copied from another writer, must be identified by the use of quotation marks, block quotations, and documentation with specific citation of the source. Paraphrased material must likewise be attributed to the original author. As a school, intent on training men and women of integrity for the ministry Bible Institutes of America Inc. takes plagiarism seriously. Plagiarism consists of the following categories:

1. Use of another's ideas without giving credit
2. Quoting material from published or unpublished works, or oral presentation, without giving proper citation
3. Paraphrasing material, whether published or unpublished, written or oral, without proper citation

Any student found guilty of plagiarism will be subject to, but not necessarily limited to, the following discipline:

1. Faculty discipline on first offense
2. Reduction of grade
3. Failure of assignment
4. Letter of reprimand

Academic Affairs Committee discipline on successive offences. Student will be subject to, but not necessarily limited to, the following discipline:

- a. Receiving an "F" for the course
- b. Dismissal for one year (three or more offenses)

Faculty is to report all cases of plagiarism to the Dean of Academics in the form of a "Plagiarism Report."

Dress Code

The following is a list of attire that is a guideline for men and women attending classes.

NO T-shirts with profane logos or language of any kind.

NO flip flops

NO exposed cleavage

NO form fitting indiscreet necklines or see through blouses

Modest dresses or skirts only

1st offense: Students will be asked to leave class and will receive an unexcused absence.

2nd offense: Students will be placed on a probation period. Violation will result in dismissal from BIOA

Classroom Attire

Students are to dress appropriately for the classroom. Students arriving to class improperly dressed will be asked to leave. They will also receive an absence.

Financial Agreement

Each student will sign and be given an awards letter from BIOA along with the student handbook. **All payments are due on the date scheduled and discussed with administration. If you enter into a month with a balance from the previous month, you will be removed from courses until the balance is current. If you are an online student, your account will be locked until balance is current. All balances, fees, and requirements MUST be met before graduation.**

Late Fees

All Payments are due on the 1st of the month. After the 5th of each month a fee of \$15.00 will be added to the students account.

Dismissal

A student terminated from the school, unless an exception is made, may be temporarily or permanently ineligible to return. The school reserves the right to terminate any student whose academic standing is too low or whose general conduct and influence are not considered to be in the best interest of the school. Rebellion, stubbornness, disloyalty, immorality and/or persistent disregard of the school's rules and regulations will be just cause for dismissal from the school. Such action may be taken by the school at any time without making a public specific explanation. Students facing the possibility of dismissal during the academic year may receive a hearing before the administration. A student may not withdraw while under disciplinary action. Terminated students are not welcome on campus unless given special permission from the Dean of Students. Those without permission are viewed as trespassers subject to arrest and prosecution.



Become an Affiliate Seminary of Bible Institutes of America

We welcome you to join Bible Institutes of America as an affiliate campus. This is an opportunity to establish a Theological Seminary in your church, ministry, organization, or community. When you become an affiliate campus of BIOA, you will hold the same Accreditation and License as BIOA. All curriculums will be provided by BIOA. All affiliate schools will receive %50 of all In-Class, Online, and Independent Study registered students. Below you will find a list of requirements and procedures for all affiliate schools:

- 1. Submit Application for approval by the Board of Directors*
- 2. \$2,500.00 one-time Affiliation fee is required upon approval*
- 3. \$250.00 annual renewal fee*
- 4. Each school will be presented with start-up marketing material. Any material needed after the initial start-up will be purchased by the school at the cost of printing.*
- 5. All registrations and fees will be submitted to the home office of BIOA.*
- 6. All funds will be dispersed to all affiliate schools between the 15th and the 20th day of each month.*
- 7. All students will pay by Paypal, Cashier's Check, or Money Order. (BIOA does not accept personal checks)*
- 8. Affiliate schools will receive a %25 referral fee on all Honorary Doctorate Degrees, and a %10 referral fee on all Chaplaincy Degrees.*
- 9. All Deans of affiliate schools will be required to go through a reference and background check.*
- 10. Each Dean will undergo an eight (4) hours training course before opening their school.*
- 11. There will be a mandatory yearly training for all deans of affiliate schools. Dates TBA.*
- 12. Any curriculums that will be used outside of what BIOA offers will be reviewed by the Board of Directors. Only after approval will the curriculums be able to be used.*
