#### **ARTICLE I**

**NAME** 

The name of this corporation is Clan Moncreiffe Society, Inc.

# ARTICLE II OBJECTIVES

The purpose of this corporate Society shall be:

- A. To provide educational, charitable, cultural, recreational, historical, and social benefits to descendants of Moncreiffe/Moncrief and any septs of the Clan Moncreiffe and to the general public in the areas of Scottish culture and ways.
- B. To promote, perpetuate, and encourage Scottish traditions and heritage by acquainting and disseminating information to descendants of Moncreiffe/Moncrief and any septs of the Clan Moncreiffe and to the general public by all available means.
- C. To further promote, perpetuate, and encourage Scottish traditions and heritage by serving as Clan sponsors at various Scottish Highland Games and Gatherings.
- D. To preserve and promote the traditions, customs, and heritage of Clan Moncreiffe.
- E. To promote a spirit of kinship among members of Clan Moncreiffe throughout the world.
- F. To encourage research and stimulate interest in Moncreiffe descendants in the genealogical, cultural, and historical background of their ancestors and to educate on the important contributions that Moncreiffes/Moncriefs have offered to the economic, scientific, cultural, military, and public life.

#### ARTICLE III

TIME LIMIT

This corporation shall have perpetual existence. Corporation existence shall commence upon filing with the Probate Judge of Morgan County, Alabama, USA.

#### ARTICLE IV MEMBERSHIP

Persons, regardless of age, sex, or national origin, who profess lineal descendents of Scots bearing the names of Moncreiffe or Moncrief or variations in the spelling of these names, or have a genuine love of the Scottish traditions and heritage with respect to Clan Moncreiffe, or who will work to uphold, promote, and encourage perpetuation of the corporation, shall be eligible for membership. Eligible persons must make application to and be approved by the Society to become members. Classes of membership and dues may be established in the Bylaws.

#### ARTICLE V

#### OFFICERS AND THE COUNCIL

The business affairs of this corporation shall be managed by the Council. The Council will consist of the elected officers. Officers of the corporation shall be elected from the members and shall be members in good standing. The number of officers, terms of office, and method of selection shall be set forth in the Bylaws. The Council shall provide Bylaws to conduct Society business and is authorized to make changes as they deem necessary from time to time.

A meeting of the corporation membership shall be held annually on dates to be determined by the Council. Special meetings of the Council may be called by the President or Vice President and may be called by either of them on the written request of any member.

#### ARTICLE VI AMENDMENTS

These Articles of Incorporation may be amended at any Annual General Meeting by a two-thirds (2/3) vote of the members present, provided a written proposed amendment has been submitted to the Council at least thirty (30) days prior to the Annual General Meeting. Mail and electronic voting shall be acceptable.

# **ARTICLE VII** FUNDS AND LIABILITIES

This corporation is organized exclusively for charitable, educational, and historic purposes. This corporation will not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under section 501(c) of the United States Internal Revenue Code of 1986 or the corresponding section of any future United States federal tax code.

No part of the earnings, receipt of dues, sale of advertising, receipts of gifts, contributions, or other funds from whatever source of the corporation, shall inure to or benefit of, or be distributed to its members, officers, or other private persons. The corporation shall be empowered and authorized to make payments and distributions in the furtherance of the purposes and objectives

as set forth hereof. No part of the activities of the corporation shall be the carrying on of propaganda, or attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on:

- A. By a corporation exempt from any Federal Income Tax under Section 501(C) 3 of the United States Internal Revenue Code, or the corresponding section of any future United States federal tax code, or
- B. By a corporation, contributions to which would be deductible under Section 170 (C) 2 of the United States Internal Revenue Code or corresponding sections of any future United States federal tax code.

## ARTICLE VIII LIABILTIES

This corporation, in the furtherance of it purposes and objectives, shall be entitled to and be possessed of all of the privileges, franchises, and powers, including the borrowing of money, granted to corporations not for profit pursuant to the laws of the State of Alabama. The corporation may acquire and dispose of property, real, personal, and mixed, tangible and intangible, by purchase, exchange, gift, or otherwise without limitation as to kind or amount, and the corporation may incur debts or indebtedness, secured and unsecured, in connection with and growing out of any act or transactions arising from or in the furtherance of any of its stated or authorized purposes including fund raising, sale of advertising and any methods not forbidden by statute for corporation not for profit. The corporation's liabilities shall be limited to its common funds and assets.

The Council may, but shall not be required to, adopt Bylaws which limit the nature or amounts of such liabilities of the corporation or proscribe the method of authority of the officers to issue same.

# ARTICLE IX EXEMPTION OF LIABILITY

The private property, properties, assets, funds of any and all kinds and nature now held, owned, controlled and the same as may be acquired in the future of and by the individual incorporators, members, commissioners, officers, and agents of this corporation shall be forever exempt and untouchable by and from any liability or whatever nature, that may arise from the activities of this corporation in pursuing its stated and authorized purposes and objectives. It is hereby specified and provided that each commissioner, member, officer, and agent shall be indemnified by the corporation against expenses actually and necessarily incurred by him in connection with the defense of any action, suite, or proceeding in which he is made a party by reason of his being

or having been a commissioner, officer, or member of this corporation, except in relation to matters as to which shall be adjudged in such action, suit, or proceeding to be liable by reason of gross negligence or misconduct in the performance of his duties. No member of the corporation shall be held personally liable financially or in any other capacity in connection with any of its undertakings.

# ARTICLE X DISSOLUTION

Dissolution of this corporation must be approved by a majority vote of at least ninety percent (90%) of the members then registered.

In the event of dissolution of this corporation, after payment of all the liabilities of the corporation, the assets of the corporation shall be distributed exclusively to one or more charitable, educational, historical, or such organization(s) which at the time, shall qualify as exempt organizations under Sections 501(c) of the United States Internal Revenue Code of 1986 as amended or corresponding sections of any future law. Such distribution of assets shall be made upon a vote of a majority of the Council.
