Glenn P. Kendall, Ph.D., Founder and Executive Director of the Board of Directors for Youthaven Public Ecovillage

Glenn Kendall, Ph.D. is the Founder and Executive Director of Safehaven Public Ecovillage, Inc., which is under the auspicious of Youthaven Public Ecovillage, Inc. He has over thirty years of experience managing and administering youth, residential, evaluation, drug treatment, and management services for the children and young adults living in the innercity neighborhoods of New York City, and later in Morristown, New Jersey. He has been a founding board member on several boards including

the Morristown Unity Charter School for Sustainability. He has volunteered at ProKids as a Court Appointed Special Advocate. In addition, Kendall attended four graduate schools: Earned three degrees, a Master's Degree from Cambridge College in the area of Humane Education, a Master's from Drew University in Theological Studies, and a Ph.D. from Union Institute & University in the field of Public Policy and Social Change concentrating on improving Group Homes. He also completed a Master's Degree program from Teachers College, Columbia University. Dr. Kendall was also a nominee for the Marvin B. Sussman Doctoral Award. Additionally, he served those most in need by also using his spiritual gifts and talents. He is a trained Reiki Master, a Therapeutic Touch student of Dr. Delores Krieger of NYU Graduate School of Nursing, and a Spiritual Restoration Coach.

In addition, Gilbert Walking Bull of the Lakota Nation, the Pine Ridge Reservation, trained Dr. Kendall as a Chanupa Peace Pipe Carrier. Dr. Kendall facilitated an intentional community conference with seventy attendees during the summer of 1990. He and eighteen conference members participated in a sweat, wherein a Black Eagle materialized. Shaman Dove of the Potato Clan of the Cherokee Nation led the sweat lodge and later that day revealed to Dr. Kendall that the Eagle was a gift and a naming ceremony from "Grandfather." She told Dr. Kendall that he was known in the Cherokee Heaven as Black Eagle Soaring, at which point a Black Eagle flew overhead against a clear blue sky. Two years earlier, the Light of the *Great Spirit* ordained him and six others as ministers in Inyokern, CA.

Orsella immigrated to the United States at the age of 14. Fluent in the Languages, Kirundi and French she had to quickly learn English while attending Withrow High school where she graduated Salutatorian. Earning an academic scholarship to Northern Kentucky University, she graduated Summa Cum Laude double majoring in Finance and Business Management where she was the keynote speaker of the graduating class. Orsella then accepted a position with Kroger's Corporate offices working her way up to a Labor


### Asia Harris, B.A. Co-Chair, Asia Harris Grant Writer Cincinnati, Ohio
