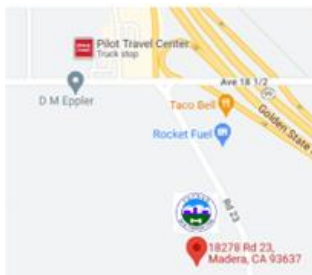

## **Directions**



From CA Hwy 99 Northbound or Southbound,  
take exit 159 onto Avenue 18 ½ and turn West toward the Pilot Travel Center.  
Turn left onto Road 23. Go past the fuel station on your left. The venue will be  
on the West side of the road.

Look for the FDTC event sign and Desert Sky Kennel drive. Follow the signs  
to the event and parking area.

## **Event and Venue Information**

To qualify, the dog must cross the start line and the finish line on its own. Handler, releaser/catcher may not step onto the track over the timer lines to assist dog.

No bitches in season may run. AKC Section 3.2 Bitches in season, or bitches which come in season after the close of entries, shall be barred from participating in the event or trial and their entry fees refunded. Notification to the Field Secretary of bitches in season must be made before or during the roll call. Bitches known to be in season shall not be brought onto the trial grounds.

All dogs will be checked for lameness upon check-in, bitches will be checked for signs of heat.

Dogs may run on any acceptable collar as permitted in Section 16 of the AKC rules and regulations for FAST CAT events. No chain collar, collar with prongs, or electronic training collar may be worn.

FAST CAT events are open to all dogs who are at least 12-months of age, are individually registered with the AKC, recorded in the Foundation Stock Service (FSS) program, individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC limited or conditional registration, or dogs enrolled in the AKC Canine Partners program. Dogs with breed disqualifications and spayed/neutered dogs are eligible to participate. A dog may enter only once per event – defined by an event number.

The Event Committee reserves the right to bar known aggressive dogs. The Event Committee reserves the right to alter the track as required by weather and/or field conditions on the day of the event.

No entry fee will be refunded if the trial cannot be opened or completed by reason of riots, civil disturbances, fire, act of God, public emergency, loss of site, extreme weather conditions, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Event Committee.

In the event of cancellation, the entrants who have pre-entered will be notified no later than 3 hours before the start of the trials. Every effort will be made to update trial information on the website, and Fresno Dog Training Club's social media presence.

Two separate events are being offered each day. Both events in a day will be run concurrently. You may use one entry form per dog to enter one or more events offered by circling the information on the entry form. Each event requires a \$30 entry fee. Late and day of show entries will be accepted until run limits are met. Conditional entries will not be accepted. Entries received with incomplete information or payment will not be counted toward the limits until completed.

Exhibitor is responsible for supplying two leashes for your dog – one for the dog to wear to the start line and be removed by the releaser, the other for the catcher to secure before leaving the run out. If you wish to provide a releaser/catcher for your dog, please bring them with you to the event. There may be club members or other volunteers available to release your dog. Toys and treats may be used by the catcher only after the dog has crossed the finish line.

Entering this event, by signing and submitting the entry form, the entrant/handler agrees they have read and will be familiar with the AKC rules and regulations regarding FAST CAT events. The Event Chairperson will have a complete copy of the rules available at the site.

Please walk your dogs only in the areas indicated for dog potty. Please do not enter the dog area/kennels of the private residence. Please pick up after your dogs.

You will be able to crate out of your car, set up outside your car. Parking area will be within a reasonable distance of the start and finish lines. Dogs must always be always secured in crates or on leash with handler. Do not allow your dog to run off leash unless on the course for timing.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.
