### **MINISTER'S REPORT 2022**

### **Rev. Michele Rowe**

[Elijah] lay down under the broom tree and fell asleep. Suddenly an angel touched him and said to him, 'Get up and eat.' He looked, and there at his head was a cake baked on hot stones, and a jar of water. He ate and drank, and lay down again. The angel of the Lord came a second time, touched him, and said, 'Get up and eat, otherwise the journey will be too much for you.' He got up, and ate and drank; then he went in the strength of that food for forty days and forty nights to Horeb the mount of God. At that place he came to a cave, and spent the night there.

### Elijah Meets God at Horeb

Then the word of the Lord came to him, saying, 'What are you doing here, Elijah?' He said, 'Go out and stand on the mountain before the Lord, for the Lord is about to pass by.' Now there was a great wind, so strong that it was splitting mountains and breaking rocks in pieces before the Lord, but the Lord was not in the wind; and after the wind an earthquake, but the Lord was not in the earthquake; and after the earthquake a fire, but the Lord was not in the fire; and after the fire a sound of sheer silence. When Elijah heard it, he wrapped his face in his mantle and went out and stood at the entrance of the cave. Then there came a voice to him that said, 'What are you doing here, Elijah?' (1 Kings 19: 5-9, 11-13)

Some of us write and some receive Christmas letters, which tend to be a summary of an individual's or family's accomplishments and transitions over the past year. Such letters tend to focus on the positive and the major events that took place. I can see the wisdom in that approach, and it could serve equally well for an annual letter to a family of faith, namely, all of you.

Over 2022, we have seen many people return to church in person and have grown our congregation on Facebook and YouTube. We hear that our online presence has been a real blessing for those unable to attend in person for a variety of reasons.

We have experienced the generosity of members and the wider community through support of our varied fundraisers and annual fall campaign. So much of our ministry is carried out by faithful and committed volunteers, some of whom attend our church and others who do not. There were baptisms and celebrations of lives well-lived, stories of faith shared, and always nourishing food for tired prophets. There were songs sung in tears and by way of joyful noise, ushering in the Spirit among us.

As 2022 comes to a close, however, I want to share with you that much of the work of the church occurs in a kind of holy and quiet space: prayer shawls draped around the shoulders of those who grieve; get well cards arriving in the mail; donations for the food bank laid in a crate; and the silence of prayers lifted for the world. Ours is often a ministry of small things where hands are held and the hungry are fed and encouragement is given to those seeking healing and recovery.

Like Elijah, we all need sustenance for the journey. We can not go it alone. This year, in addition to regular worship leadership duties, I spent a good deal of time in quiet spaces with those who were grieving, those transitioning from this life to the one beyond, and those seeking relief from trauma, old and new. These are the blessings and demands of ministry that do not engender newspaper headlines or overflowing budgets, but they are important and crucial. They matter to the God who met Elijah not in the wind, or the earthquake, or the fire, but in the sound of silence.

The value of our church's ministry in this community and beyond may not be measured in monumental accomplishments and grand public announcements. Rather, it may be seen as a ministry of small things done with great love.

There are not good enough words to express how grateful I am for all of you who make this quiet ministry possible—saints who walk softly and with little fanfare. You have continued this work through decades, years, months, or days. You are worthy of the true prophet's reward: a snack, a nap, and recognition by your God.

2023 will call us to respond to God's question, "What are you doing here?" Together, we will live into the answers.

# 2022 Financial Report Louise Forester

Thank you all for answering the call for support; it sure shows how important our church is to everyone!

Generous donations of over \$52,000 (\$16,000 more than last year) were received. This more than made up for the loss of government support provided last year (over \$12,000).

In addition, we were able to hold more fundraising activities this year which raised more than \$16,000. This is \$5,600 more than last year. These included:

- Funeral teas
- Garage sale
- Online auction
- Cookie sales
- Cold plate & Fowl suppers
- Dessert socials

The increase in revenue almost covered 2022 operating expenses resulting in a small draw on capital of \$1,393.

Your finance committee and council continue to diligently oversee the operating expenses in spite of rising costs. The church will need your continued support in 2023 to cover its expected (budgeted) operating expenses (\$110,038) and keep the doors open.

Thank you so much to Dena for the numerous hours you spent providing more than just accounting services to our church; it is so appreciated.

- Established an affirming Task Group
- Worked on finding ways to support the community outreach ministries and camps here in the region – working with Edge to establish a position for grant support.

- Discontinued the Regional Assessment for 2021 but established a Community Outreach fund where congregations could donate monies that would be distributed equally among the ministries and camps in the region.

- Continue to offer mission grants to North and South Saskatchewan Chaplaincies, ICM, RAPM, Micah Mission, Parkland Restorative Justice, United Church Camps, and other ministries in our Region.
- Support and resource for letter writing in response to Camp Hope and the change in the Saskatchewan Income Support Program (SIS).
- Support and financial considerations for the implementation of the Rural Connect Program in Living Skies Region.
- Financial Support for UCW, clusters, learning opportunities, youth events.
- On-going work with the Regional Youth Staff position.
- Encouraged participation in the Tri Region Snow and Ice Art competition.

These are just some of the highlights of the work that has taken place this year. It hasn't always been easy, but grace has been abundant in our discussions. As we continue our work, please hold the executive, the staff, and the leadership

### CAMP SHAGABEC - YEAR IN REVIEW: 2022 Dave and Kat Fletcher

Camp Shagabec sold out all the camper spaces again this year and set a record for the number of camper registrations, but, despite this, still ended up in the red due to property improvements costs, fuel costs, and a jump in insurance and food prices. This was also the weakest year on record for donations to the camp. We usually see \$20 - \$50 000 in donations come in, but last year we received less than \$5000.

The camp continues to be a shining beacon of love, joy, and happiness for kids from around the prairie provinces. We have received numerous glowing reports back from parents discussing how much their kids have loved getting back to overnight camps after a two-year hiatus.

There were 144 volunteer positions filled over the course of the last summer. Without this level of volunteerism, Shagabec would not be able to operate. The volunteer staff is incredible and bring so much energy and joy to the camp. There were 7 paid staff positions filled as well. These staff members are at the camp for the entire summer and lead the camps as well as cook, manage, and do the bottle recycling program. Bottle recycling requires 2-3 people to collect and sort bottles and cans from 200 pick-up sites around the Cypress Hills. In total, we were able to collect close to \$17 000 from this contract and supplement the cost of running the camp.

Property improvements highlights:

- New staff cabin built
- New dining tables and benches being constructed (going back to the rectangle tables).
- 25+ large trees fell over the winter and spring they were chopped up and cleaned up.
- Shaga-gate installed
- Foundation on Cabin 8 improved (new beam installed)

### **Bathroom Renovation Update:**

After several summers of pushing off the bathroom renovation, we officially began upgrading the washhouse. Grady Rowley and his dad, Dave Rowley have graciously taken on the construction reno of the bathrooms. The "boys" and "girls" sides, along with the laundry room, are being upgraded.

Structurally the building will remain the same; however, the laundry room is being divided in half to accommodate a "gender accessible" bathroom (i.e. a bathroom that will be classified gender neutral but consist of features that make it wheelchair accessible) that will also serve as the paid-staff shower and washroom. The remaining portion of the old laundry room will remain exclusively a space for washing clothes and other storage. Each room will have a separate entrance going forward.

The construction aspect of the renovation is proceeding well. Thus far, the biggest issue we have encountered was removing portions of the concrete floor to install new drains where required. As of right now, most of the progress is concentrated on the girls' side (it is more or less ready for paint), but here is a list of what's been finished:

- All of the necessary concrete has been removed from all three spaces.
- o A new door was installed for the gender-accessible (G-A) space.
- Walls have been framed in the G-A space.
- Walls for shower stalls and walls to hide the plumbing and wiring have been framed in the Girls and Boys'.
- New lights, switches, motion detectors, and fans have been wired into the Girls and Boys'
- Rough-in plumbing for new showers have been installed in the Girls' and Boys'.
- Sinks and taps have been ordered and delivered.
- o Countertops have been acquired, and holes for sinks have been cut.
- Showers for all three spaces have been ordered and delivered, two units have been installed in the Girls side. Boys side will be installed shortly

New windows for the Boys and Girls have been ordered.

We were fortunate to source all of the showers at 60% the price we anticipated, which should give us some more wiggle room in the budget, but the most significant cost will still be the stall partitions for the toilets and urinals. We expect the windows to arrive in mid-December or later. The biggest hold up is going to be painting. With the temperatures dropping, it will be impossible to paint until spring.

Timewise, we anticipate there being no issue with finishing the project before the rental season, but if time looks to be an issue, we will leave the laundry room for last. Moreover, we may look at having a "painting party" once we are close to the finishing portion of the renovation. Dave-o has acquired a large paint sprayer which should help with the large pieces, such as the ceiling, but many hands might better tackle the smaller tasks.
