#### Using Indirect Evidence and Sibling Relationships to Prove Mary Duey as the Mother of Samuel Joyce


Samuel Joyce was born in 1828 and died in 1864 during the Civil War. Samuel's father, George, died in 1836 when Samuel was only seven years old. The probate and guardian papers generated from George's death provide evidence of their father-son relationship. However, Samuel's mother was not mentioned in any of these papers. No birth or baptismal record for Samuel has been found nor has any other direct evidence of Samuel's mother's identity.

#### Introduction

Samuel Joyce's father, George Joyce, married Mary Duey on 13 Jan 1820 in the First Presbyterian Church of Carlisle in Cumberland County, Pennsylvania. They had two sons, Jacob and John, who were baptized in the same church. The baptismal records provide the parents' names of George and Mary and therefore serve as direct evidence of these first two sons' parentage. Three more children were born into the family after the first two sons. The Joyce family moved from Pennsylvania to Ohio sometime between 1823 and 1825, between the birth of the second child and the

third child.<sup>3</sup> In the new Ohio location, no church records have been found for the family. Thus, no baptismal records exist documenting Mary (Duey) Joyce (or someone else) as the mother of the three youngest children: Caroline, Samuel and Mary Matilda.

The following family tree depicts the Mary (Duey) Joyce family that includes direct evidence only. The three youngest children are linked to their father, George Joyce, through probate documents, but have no direct evidence linking them to Mary (Duey) Joyce.



#### A Lack of Vital and Church Records for Samuel

Samuel Joyce's 1828 birth in Ohio was during a time when civil registrations of births were not required.<sup>5</sup> Ohio required county-level registrations of births and deaths in 1867, nearly 40 years after Samuel's birth.<sup>6</sup> Thus, not surprisingly, a birth record for him could not be found.<sup>7</sup>

In the absence of a birth record, often a baptismal record provides both parents' names. No baptismal record could be located for Samuel using both a general search as well as a targeted search within local church and Presbyterian Church records.<sup>8</sup>

In more recent marriage records, the parents'

names can often be found on a marriage record. No marriage was found for Samuel and his wife, Eliza Ann Correll.<sup>9</sup> Even if one could be found, it would be unlikely that a 1848 Ohio marriage record would contain the names of the bride's and groom's parents. Samuel Joyce died during service in the Civil War and then Eliza lived for many decades afterwards. This entitled her to a pension. Eliza's Civil War Widow's Pension File validated that no civil marriage record ever existed because the Justice of the Peace who performed the ceremony did not create one.<sup>10</sup> Though two witnesses to the marriage validated the marriage, the lack of a record allows no opportunity to learn of Samuel's parents.

Shortly after enlisting and serving in the Civil War, Samuel died of typhoid fever on 12 Jul 1864. 11 This military death record was quite generous in providing personal information about the solider. It described that Samuel was born in Wayne County, Ohio, he was 5' 11" tall, had blue eyes and auburn hair, and that he was a carpenter by trade. Unfortunately, the names of the soldier's parents were not a part of the discharge form. 12 No civil death record was generated by Samuel's death either, which could have been a source of parents' names.

Samuel's military death record notes that he was "embalmed to be sent home." His body was buried in the Wooster Cemetery in Wayne County, Ohio. Other headstones in the same lot as Samuel's appear to have no familial relationship. However, his uncle and aunt, John and Isabella Joyce, are buried in the same cemetery. Samuels' father, George, was buried approximately sixteen miles away in the Lakeville Cemetery, Holmes County, Ohio. No grave for a Mary (Duey) Joyce was found in either of these locations or other nearby cemeteries.

#### **Exploring Samuel's Other Records**

Having exhausted the search of Samuel's vital records to identify Samuel's mother, the search was broadened to include other sources that may typically include parents' names. Census records could not recreate his nuclear household because in 1830 and 1840 only the heads of household were recorded. One 1863 newspaper account listed Samuel Joyce on the Committee of Arrangements from Relief Fire Company Number 4 for the Firemen's Celebration on the Fourth of July 1863. But no other newspaper articles were found to help identify

Samuel's parents. No obituary was found for Samuel.<sup>19</sup>

In the Civil War Widow's Pension file, a family Bible was referenced to validate Eliza Ann Correll's birthdate.<sup>20</sup> However, no indication to Samuel's parents was made in the reference and the family bible has not been located.

Though a variety of documentation for Samuel Joyce exists, none of it references his mother directly or indirectly. So, other paths must be taken such as exploring his sisters' and parent's information.

### Records of Samuel's Siblings – Caroline and Mary Matilda

Samuel's older sister, Caroline, was born on 21 Jul 1825.<sup>21</sup> No birth or baptismal record has been found, and thus provides no evidence of her parents' names. The 1830 census record for George Joice<sup>22</sup> records one female under the age of five, which confirms that there was a female child of Caroline's age in the household during this time.

On 26 Oct 1843, Caroline married Robert T. Thom [sic] in Holmes County, Ohio.<sup>23</sup> These early marriage records provided very little insight into the lives of our ancestors. The limited information included the groom and bride's names, county and state, date of the marriage, date of the return, and who performed the marriage. Thus, no information regarding Caroline's parents was provided.

Caroline and Robert Thome had one son, John R. Thome. It is through his 1910 death certificate that we confirm that his mother, Caroline (Joyce) Thome, was born in Ohio.<sup>24</sup> This validates that the family moved from Pennsylvania to Ohio between the births of John and Caroline. Additionally, this explains why only the first two children, Jacob Duey Joyce and John Joyce, had baptismal records because they were the only two children baptized while the family lived in Pennsylvania near a church whose records are available today.

Caroline (Joyce) Thome died on 15 Nov 1845. Only one record of her death has been found which is a transcription of headstones in the Lakeville Cemetery, Washington Township, Holmes County, Ohio<sup>25</sup> (the headstone itself can no longer be located or identified<sup>26</sup>). This record provides no clues to her parentage, but it is insightful to note that she is buried in the same cemetery as her father, George Joyce.<sup>27</sup> No civil death records were required in

Ohio until 1867, therefore there is no death record or certificate for her.

Samuel's younger sister, Mary Matilda, was born 5 Oct 1834.<sup>28</sup> No birth or baptismal record was found and therefore provides no evidence of her parents. Mary Matilda's record of marriage to Joseph R. Peckham in 1854<sup>29</sup> provided no more information than her sister Caroline's did, thus there is no evidence on the marriage record of Mary's parents' identities.

Mary Matilda (Joyce) Peckham died 5 Apr 1902 in Holmes County, Ohio.<sup>30</sup> Most Ohio death records at this time were ledger-based, not certificate-based. Mary's ledger did provide columns for parents' names but these were left blank for nearly all entries in the book including Mary Matilda's.

If evidence were found linking Samuel's sisters, Caroline and Mary Matilda, to Mary (Duey) Joyce, then it would support the argument that she was also Samuel's mother. However, no such evidence was found.

## Records of Samuel's Parents - Mary Duey & George Joyce

Mary (Duey) Joyce seemed to have disappeared from any records after the baptism of her second son, John, in 1823. There was no link to her being the mother of Caroline, Samuel and Mary Matilda. Likely events for Mary (Duey) Joyce may have been another marriage or even her death after John's birth. No record of either one was found.

Between 1829 and 1835, George Joyce purchased three pieces of land in Wayne and Holmes Counties, Ohio.<sup>31</sup> It was common during this time period and in this area to omit a wife's name from the deed as a grantee. This was the case with these three deeds. None of them included a mention of a wife for George. However, a little over four years later on 14 Sep 1833, George Joyce sold one of the pieces of land for \$1000.<sup>32</sup> It was typical to include a wife's name as a grantor during this time period and geography. And fortunately that was the case.

The deed reads: "Know all men by these presents [sic] that George Joyce and Mary Joyce his wife..."<sup>33</sup> This gives evidence that George Joyce was married to a woman named Mary in 1833. However, it can't be known for certain it was Mary Duey especially with a name as common as Mary.

George Joyce, Samuel's father, died in 1836. Five children were recorded in the probate file, specifically in guardian papers.<sup>34</sup> The five children were noted with birthdate references as follows:

Jacob Duey Joyce b 24 Feb 1821
John Joyce b 14 Feb 1823
Caroline Joyce b 21 Jul 1825
Samuel Joyce b 31 Aug 1828
Mary Matilda Joyce b 5 Oct 1834

No mention of the children's mother was made in these guardian papers. A lack of the widow's name in the guardian records is not unusual for this time period in Ohio. It has no bearing on if the mother of the children was living or not. The guardian named for the children was George Ligget<sup>35</sup> and appears to have no kinship to the family but was a close neighbor.

A will or probate record can be a rich source of family information. If Mary was mentioned in her parent's wills or probate records, it could prove she was living during a certain time period and with what name. However, no will or probate record was found for either Conrad or Rachel Duey, Mary's parents.<sup>36</sup>

An extensive review of George Joyce's 68-page probate file included monies due to and from the estate. An excerpt from one 1842 administrator's affidavit reads "...also that he paid Mary Rowland the sum of two dollars and eighty eight cents who was formerly the widow of the deceased..." 37 as shown in the image below. Thus, a Mary Joyce had been married to the deceased, George Joyce, and she had married a man with the surname Rowland sometime after George Joyce's 1836 death and before this 1842 affidavit. Again, there is no proof that it was Mary Duey.

Many Nowlands the num of two dellars and righty cipted cents who was formerly the window of the decard.

Though no marriage record could be found for Mary Joyce and a man named Rowland,<sup>38</sup> the couple was identified through census and other records. In the 1850 census,<sup>39</sup> the household was enumerated as follows:

Name		Age	Gender	Place of Birth

\* The enumerator appeared to make an error on the gender of this child. The name is clearly written as Elmer and he is documented in other Rowland family records.

Elmer was John Rowland's son from a prior marriage. 40 Matilda was likely the Mary Matilda from George and Mary (Duey) Joyce's marriage and of the appropriate age corroborating the guardianship records. And James H. was likely a child of John Rowland and Mary (Duey) Joyce Rowland. 41 The other Joyce children were old enough to be out of the household and living on their own. Yet, there is no proof that this Mary was Mary Duey Joyce.

James H. Rowland appears to be the only child from the hypothesized union of Mary (Duey) Joyce Rowland and John Rowland. James moved to Indiana and died there on 25 Mar 1915. His Dekalb County Death Certificate was recorded with his parents' names of John Rowland and Mary Dewey. The spelling of Dewey was a common variant of Duey at this time. It is interesting to note that her maiden name was referenced and not her married name of Joyce. This final piece of the puzzle solidifies the case that Mary (Duey) Joyce married John Rowland after George Joyce's death.

No obituary or death record could be located for

Mary (Duey) Joyce Rowland. Her headstone is located in a Holmes County cemetery with the inscription "Mary wife of John Rowland." 42

#### Conclusion


There is no direct evidence that Mary (Duey) Joyce was the mother of Samuel Joyce or his sisters. Baptismal records prove that Mary was the mother of Samuel's two older brothers, Jacob and John. Guardianship records from the death of George Joyce prove that the five children were his, though there was no record of the children's mother.

In one 1833 land transaction, George Joyce sold land and as was typical of the time period, the reference to the grantors included the wife's name. In this case it included Mary Joyce. Thus Mary was still alive after the birth of Samuel and likely to be his mother. However, an argument could be presented that this Mary is a second wife. No maiden names were mentioned and the given name of Mary was common.

George Joyce's 1842 probate file referenced his widow Mary Rowland. This indicates that she had married someone named Rowland sometime after George died in 1836 and before the 1842 affidavit. Again, it could be argued that this Mary could be a second wife to George, and not Mary (Duey) Joyce.

However two key pieces of evidence solidify that Mary (Joyce) Duey was the new Mrs. John Rowland. First, Matilda, George Joyce's youngest child often called Mary Matilda, was living in the 1850 Rowland household with her mother, Mary Duey, and her stepfather, John Rowland. Second, the death certificate for James H. Rowland includes his mother's name of Mary Dewey. Therefore, it can be concluded that Mary Duey Joyce Rowland was the mother of Samuel Joyce.

The following tree depicts the Joyce family composition proved using indirect evidence and sibling relationships.
