- ❖ You may close earlier/stay later; however, all booths must be removed by Saturday, June 12 by 6:00 p.m.
- ❖ Must provide your own tables/chairs/tent (no rain date/refund in the event of inclement weather)
- ❖ Full event details (with booth location) will be emailed 3 weeks prior to event
- ❖ Application and payment are due by May 1, 2022
- ❖ Fees are not refundable after acceptance.
