Call to Order: by Jerry Duden at 6:54p.m.

Pierce Co Conditional Use Permit: Property owner, Bruce Chamberlain shared an overview of his vision for Varmland Draw, a Farm-stay VRBO and a mixed-stream, agricultural business that he and his wife are working on at W1495 130th Ave in Maiden Rock. He showed a Design for the property and what it will include for buildings, livestock, flowers, etc. Several people asked questions.
