

TOWN OF MAIDEN ROCK COMPREHENSIVE PLAN COMMITTEE
“Minutes/Notes” from June 2, 2025

The Town of Maiden Rock Comprehensive Plan Committee held its first meeting on June 2, 2025 at the Town Hall at 6:30 p.m. Present were: Carl Nelson, Charlotte Randers, Terry Timm, Mary Anne Wise, Randall Erickson and Judy Krohn. Town Supervisor Al White was unable to attend. The Committee consists of former Plan Committee members (Charlotte & Randall), and volunteers (Terry Timm, Mary Anne, Judy, Al) who will review the Town's Comprehensive Plan (adopted in 2008) and update pertinent data and revise language as deemed necessary.

Carl Nelson was unanimously delegated to Chair the Committee, Randall Erickson will take care of posting our meeting announcements in 3 places (Town Hall, Lund Fire Department & Hiawatha Bank) at least 24 hours in advance of each scheduled meeting. Judy Krohn volunteered to keep notes during the meetings. Charlotte & Mary Anne volunteered to work together to prepare a residents' survey to inform our deliberations.

We decided that it would be helpful for each of us to have printed copies of the Comprehensive Plan; Carl will check into using the Town's printer to reproduce the documents for each member, or we will request funds from the Town to have the documents printed elsewhere.

Judy will contact Geoffrey Black, who is working on the Town of Stockholm's Plan update to gather strategies and procedures he is using in his work.

We will invite Jerry Duden or John Danneker to attend our next meeting to help identify current and future needs the Town may wish to incorporate into the plan. We agreed to keep our meetings about 90 minutes in length. The Committee's progress will be shared at regular Town Board meetings.

Our next meeting will be Monday, June 23, 2025 at the Town Hall; 6:30-8:00 p.m. Members are encouraged to read and be ready to discuss the first 51 pages of the current plan. The meeting was adjourned at 7:45 p.m.
