



Deposit Agreement

- This contract is an agreement between Great Plains Frenchies, LLC (referred to as seller from here on out) **NAME** (referred to buyer from here on out) for the seller to hold a puppy of the buyers choice until the puppy reaches 8 weeks of age.
- A non-refundable deposit in the total amount of **\$000** was paid to the buyer to reserve the previously mentioned puppy on **XX/XX/XXXX** with the buyers intent to take ownership of the puppy by the following agreed upon dates: No earlier than **XX/XX/XXXX** and no later than **XX/XX/XXXX**, for a total cost of **\$000**. If the total cost is not paid in full by the agreed upon dates, or if the buyer does not pick up the puppy by the agreed upon dates, the deposit and puppy will be forfeited by the buyer and the hold on the puppy will be released. If alternate agreed-upon dates are arranged to accommodate unforeseen events in the future, a new contract will be provided to the buyer listing the new dates.
- Deposits are non-refundable, with the only exception being that the puppy should become too sick to be released from our care or should die prior to the agreed upon dates. Should this occur, the buyer would have the choice of a monetary refund in full or the option to choose another puppy, if one is available.
