Forms of Payment

Lawn sentiments gladly accepts most major credit cards. Simply click the button on the emailed invoice to pay with a credit card. Other payment options can be discussed if needed.

Tips

Prior to your delivery date, please mow your yard and clean up any debris so we have a blank canvas to create your sentiment.

Please ensure the ground area is soft enough for our stakes to be inserted. You can test this with a screwdriver. If you can easily insert a large screwdriver into the ground, it is soft enough. If you find the ground is too hard, please water the area until the ground softens.

Installation & Removal

We will make all efforts to deliver your sentiment based on your schedule, prior to the event. Pickup will be the evening of your event or the following day.

Refund Policy

All yard rentals must be paid in advance.

You will receive a full refund if the following applies:

*Extreme weather conditions prevent us from setting up the display.

*You provide 48 hours notice of cancellation

*You will receive a FULL Refund if we are unable to set up your display due to inclement weather, unsafe road conditions, natural disasters or other acts of God.

You will not receive a refund if any of the following applies

- *The homeowner stops us from setting up the display.
- *The homeowner calls us and asks us to remove the display
- *You give us less than 48 hours notice to cancel.
- *You have given us the wrong address or date.
- *We are unable to set up the display due to subdivision or community rules or a security guard that wont allow setup.
- *The homeowner has a dog loose on the property.
- *A lack of grassy/gravel area to stake the signs
- *Any other reason, beyond our control preventing us from setting up the display.

Theft & Damages

Our signs our wind and rain durable. Please notify us immediately if you notice any damage to signs due to weather. Our signs are not designed to withstand climbing by children. Please do not allow children to play on or near the signs. If any vandalism, damage, or theft occurs, please contact us right away. Due to vandalism, damage, or theft, we may not have a replacement available but will do our best to provide a replacement/substitution. Please note that renter will be held liable for any damages, theft or vandalism.

Please do not move or take down the yard sign display. If you would like the display moved to another location in your yard, please call and we will do our best to accommodate your request. Please note that a trip charge will apply. We do take pictures of our installs to ensure quality at time of install/pickup. The pictures of your display may be used for advertising purposes.

Once the display is in place, please do not mow or weed eat around the display as this will cause damage to the signs. If you have a lawn care service, please let them know ahead of time your delivery date to ensure they do not mow after setup. As the renter you will be responsible for damage signs.

PLEASE ALERT US IF YOU HAVE A SPRINKLER SYSTEM! We are not liable for any damage to sprinklers as we cannot see any underground lines. Same applies to dog fences or any other underground systems that may be in place.

Lawn Sentiments and its owners/employees are not responsible or liable for any injury to any person or personal property that may be caused by the display, during the transportation, setup or take down of any display.
