The inherent risks may include, but are not limited to, the risk of bodily injury, property damages: the propensity of equines to behave in ways such as; running, bucking, kicking, rearing, biting, bolting, shying, spooking, stumbling, falling or stepping on, that may result in an injury, harm or death to a person (or persons) on, or around them; unpredictability of equine's reactions to such things as sounds, sudden movement(s) and/or unfamiliar objects, persons or other animals; certain hazards such as surface and substance conditions; collisions with other animals and/or objects; the limited availability to emergency care; and/or the negligence and/or deliberate act of another person(s); and the potential of a participant to act in a negligent manner that may contribute to injury to the participant and/or others, such as failing to maintain control over the equine or not acting within participant's ability, whether under instruction and/or supervision or not. ACTIVITY RISK CLASSIFICATION - Horseback riding is classified as RUGGED ADVENTURE RECREATIONAL SPORT ACTIVITY, and that there are numerous obvious and non-obvious inherent risks always present in such activity despite all safety precautions. According to NEISS (National Electronic Injury Surveillance Systems of US Consumer Products) horse activities rank 64th among the activities people relative to injuries that result in a stay in US hospital. Related injuries can be severe requiring more hospital days and resulting in more lasting residual effects than injuries in other activities. (Initial here: _____)

NATURE OF RIDING HORSES - No horse is a completely safe horse. Horses are 5-15x times larger, 20-40 times more powerful and 3-4 times faster than a human. If a rider falls from a horse to the ground it will generally be a distance of from 3 1/2' to 5 1/2 feet, and impact may result in injury to the rider. Horseback riding/driving is the only sport where one much smaller, weaker predator animal, the human, tries to control and become one unit of movement with another much larger, stronger prey animal, the horse, with each having a limited understanding of one another. If a horse is frightened or provoked it may divert from its training and act according to its natural survival instincts which may include, but are not limited to, stopping short, changing direction, or speed at will; shifting its weight from side to side, bucking, rearing, biting, kicking or running from danger.
