I understand that any supplements and/or medications supplied by me (or the vet on my behalf) will be
fed to my horse/pony at no additional cost to me.

I understand and agree to pay my monthly board bill by the 25th of the previous month. My first
payment is due upon arrival of my horse to JL Performance Horses LLC. I understand that bounced

checks are subject to an additional \$65 fee plus 15%. Late payments are subject to a 15% late fee plus \$100 per month (or portion). I agree to keep my account current to avoid any interruption in services. I understand finance/late fees are NOT waived and I am responsible to pay my bill.

All efforts are made for a subsequent successful sale. I understand that JL Performance Horses LLC retains a 20% commission on subsequent successful sale of horse/pony. \$450/monthly
